Narrative:

On March 9, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Armstrong (Armstrong) received medical records from Southwest General Medical Center for care provided to Bryan Bailey (Bailey). The records were provided as a paper copy pursuant to a search warrant.

The records were electronically copied and saved on a CD as a .pdf file titled *2023-03-09 Medical Records – Bryan Bailey*. They have been stored in the BCI SIU case file as Reference Item D. The medical records consisted of 160 pages which documented the extent, nature, and limited history of the medical conditions Bailey received care for. They further provided details regarding Bailey’s evaluation, the treatment provided, and medications administered to Bailey on October 18, 2022.

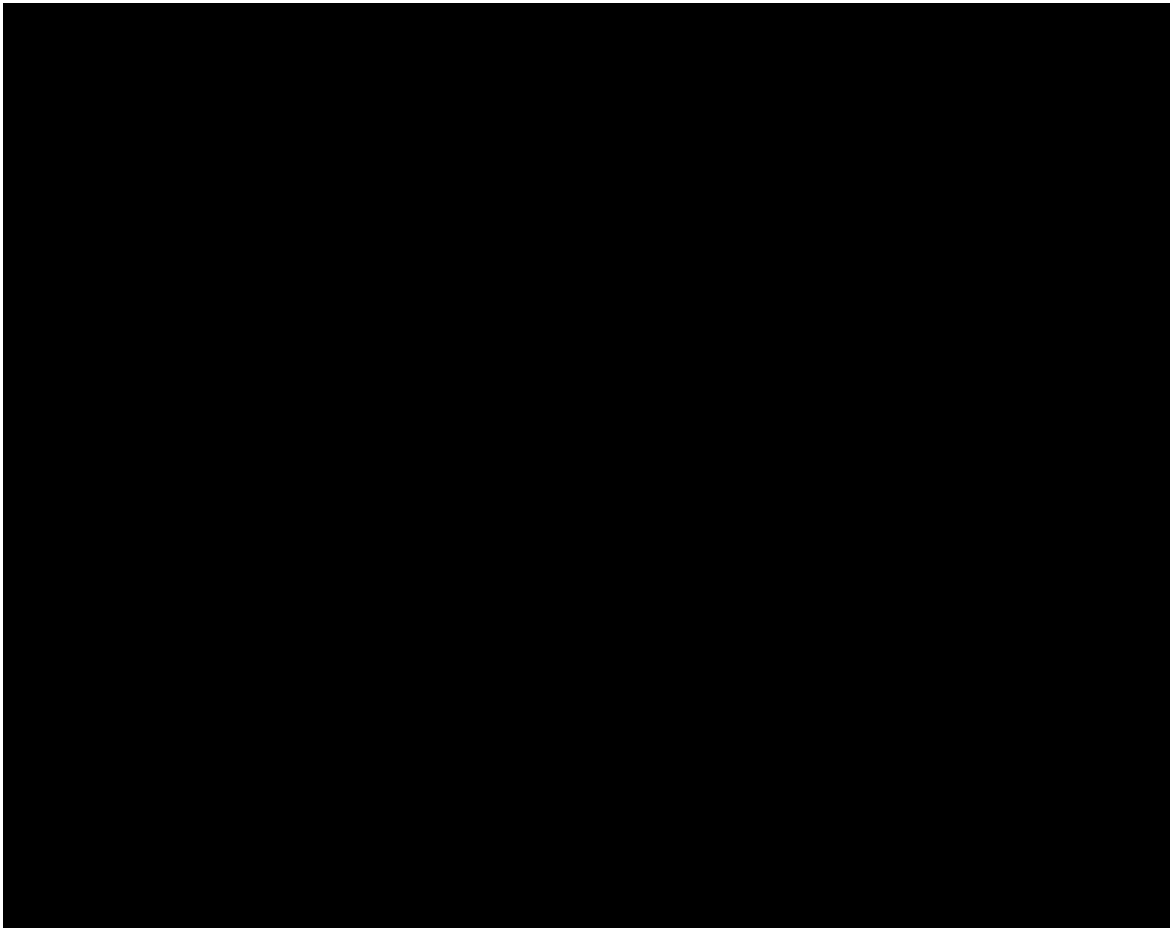

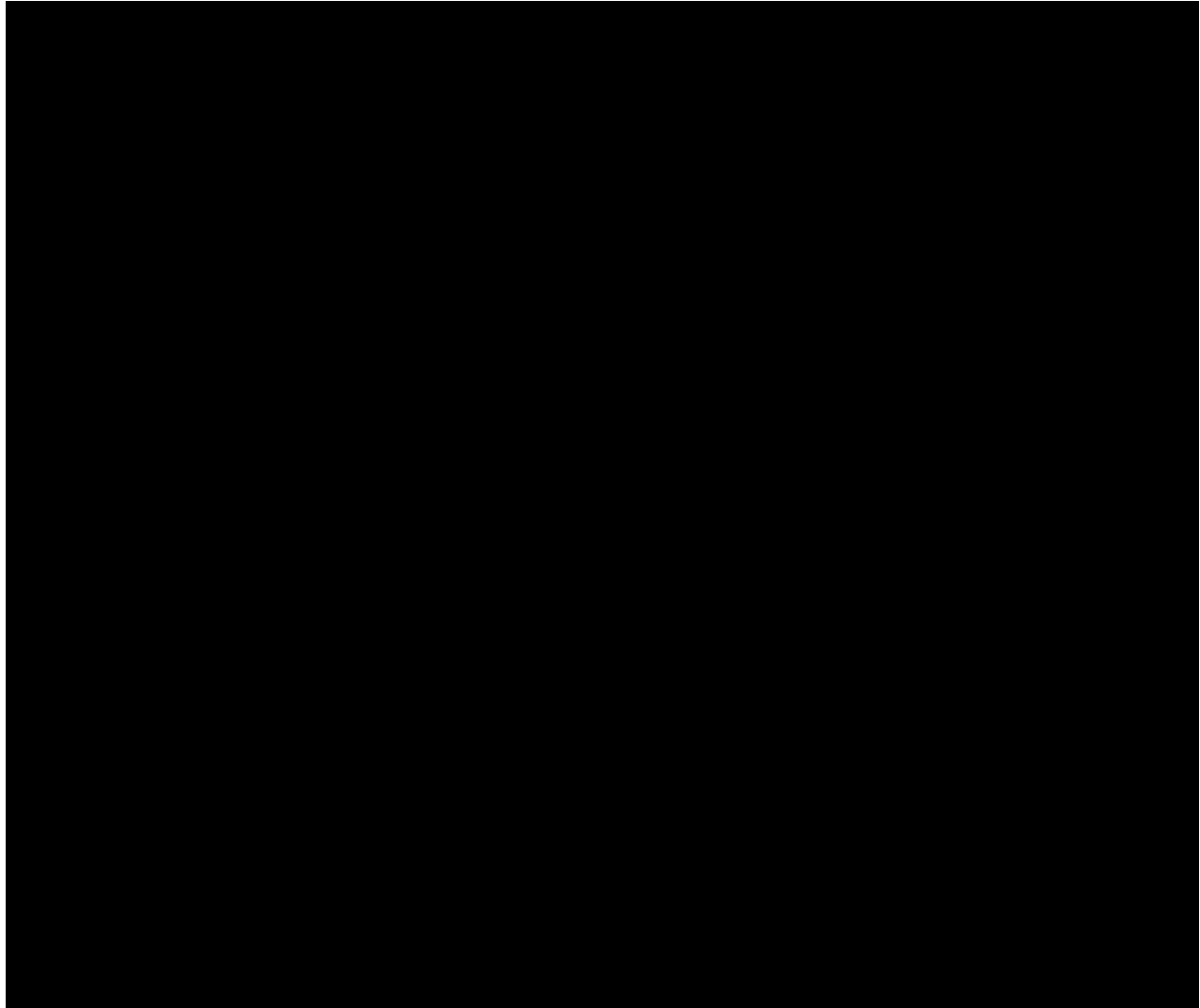

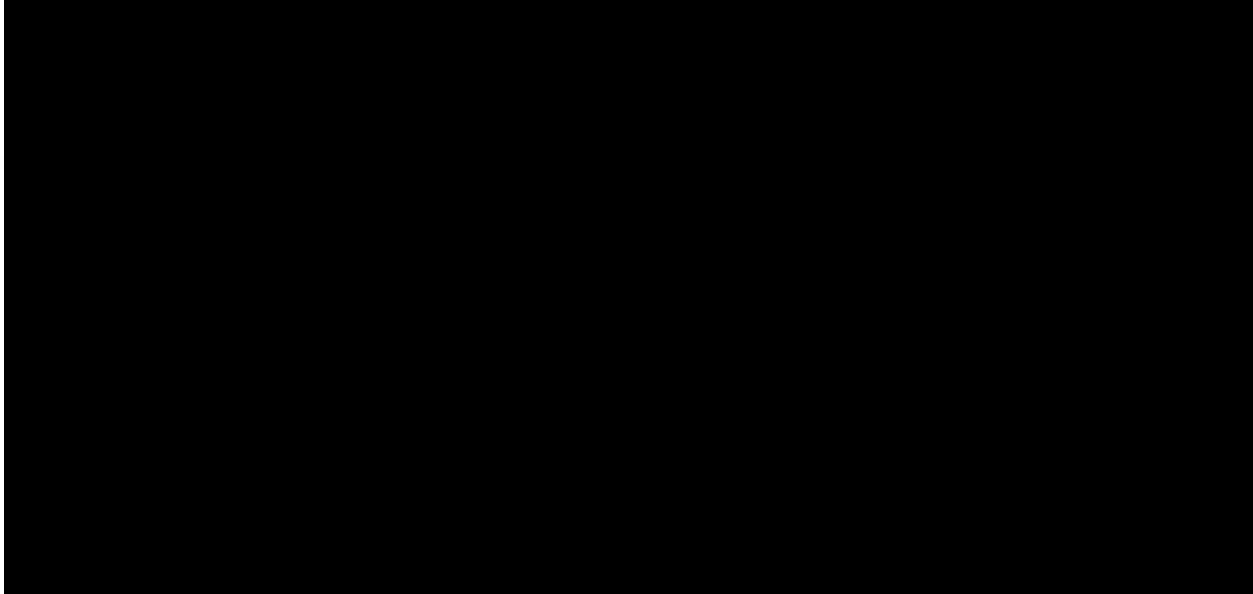

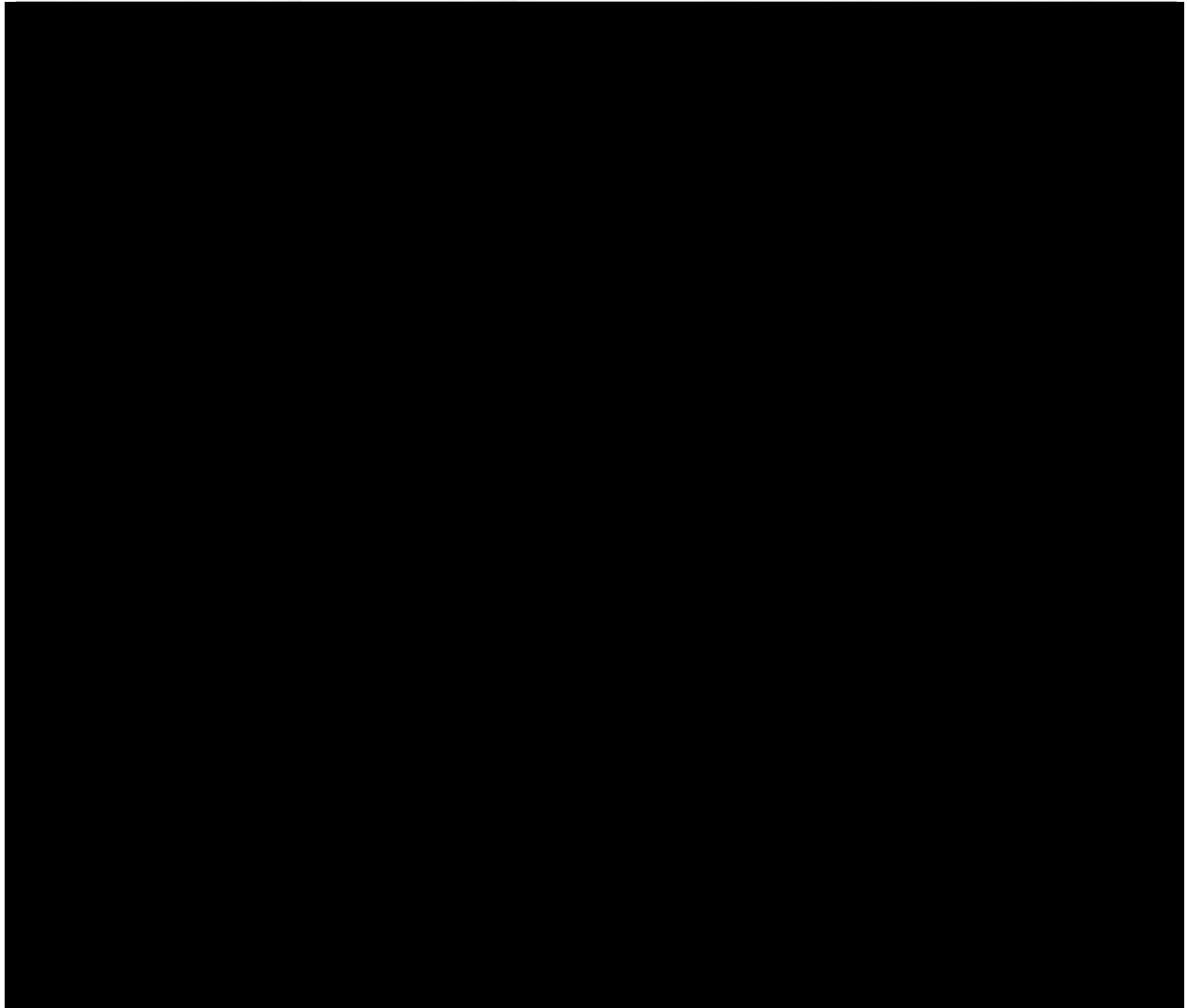

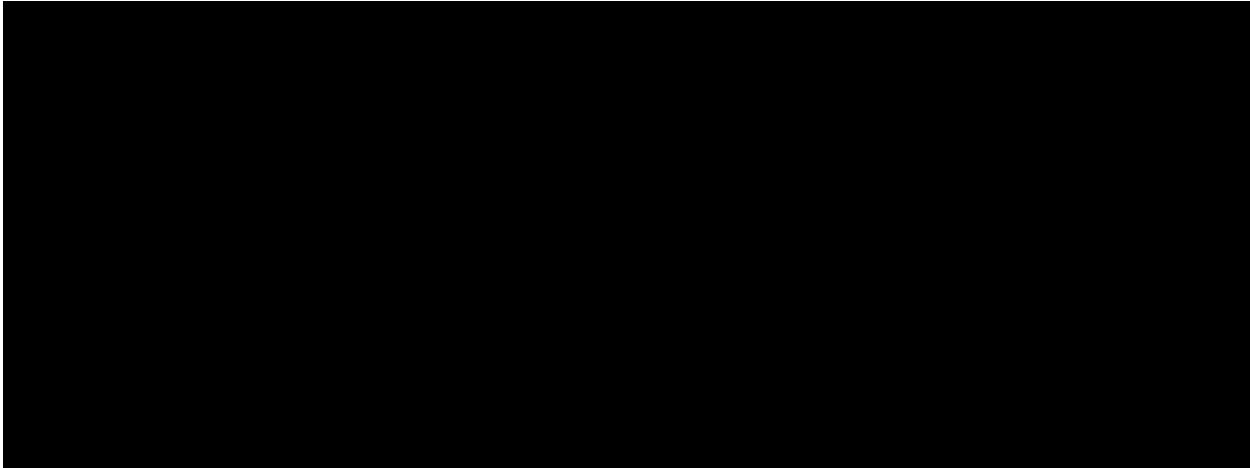

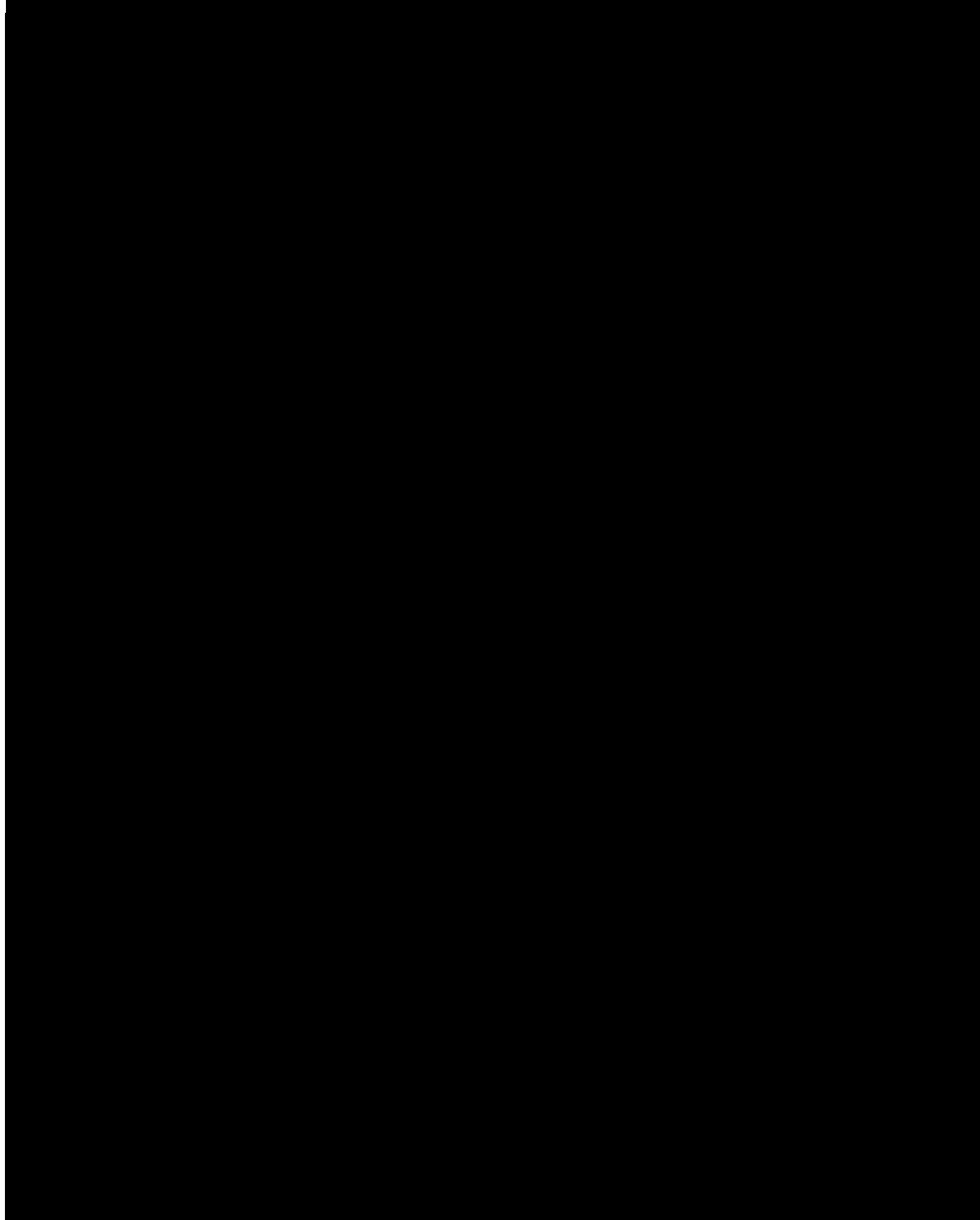

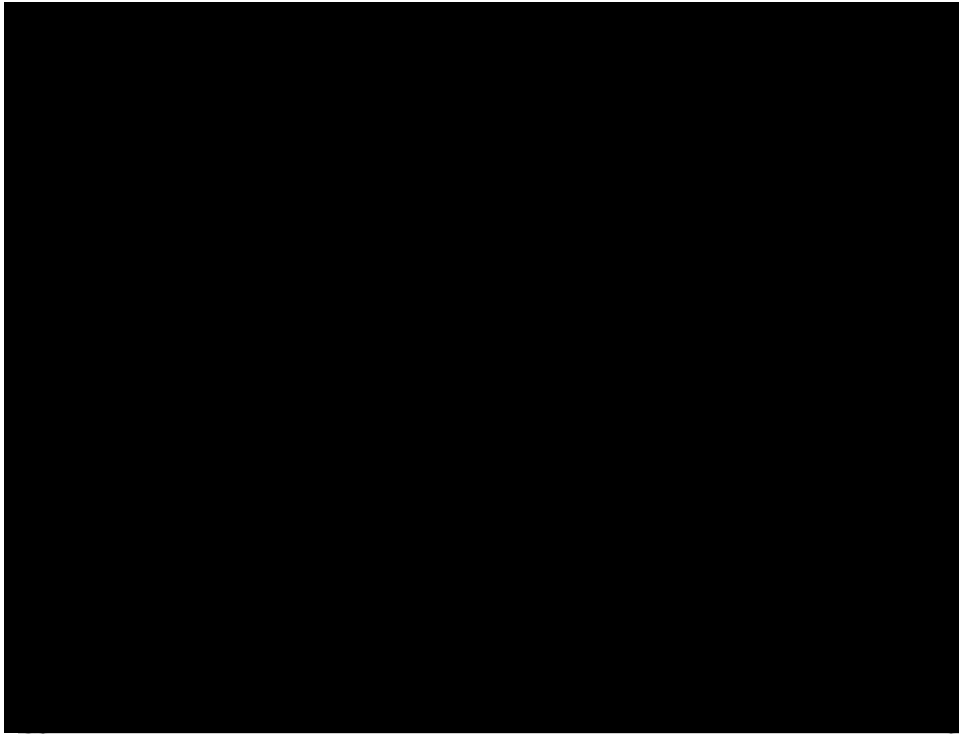

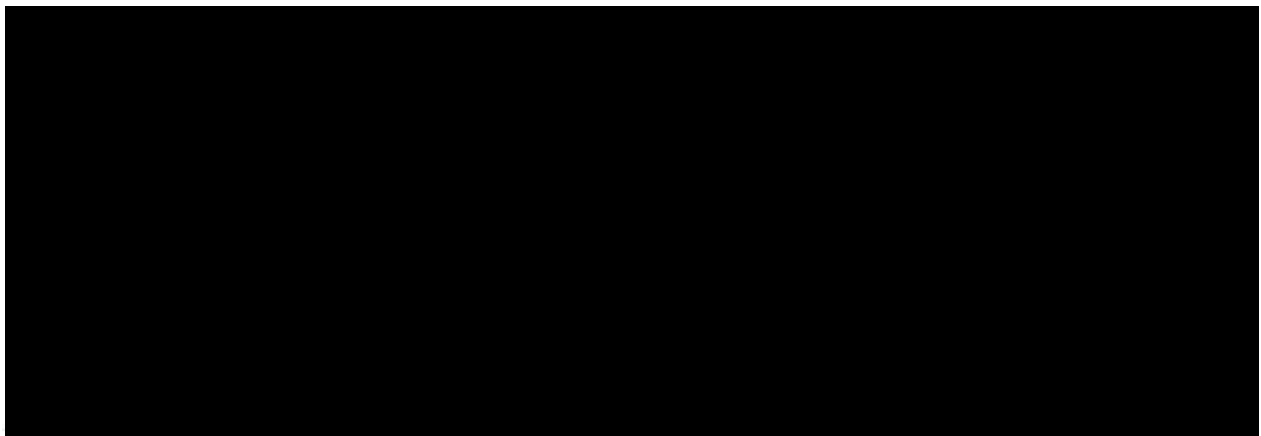

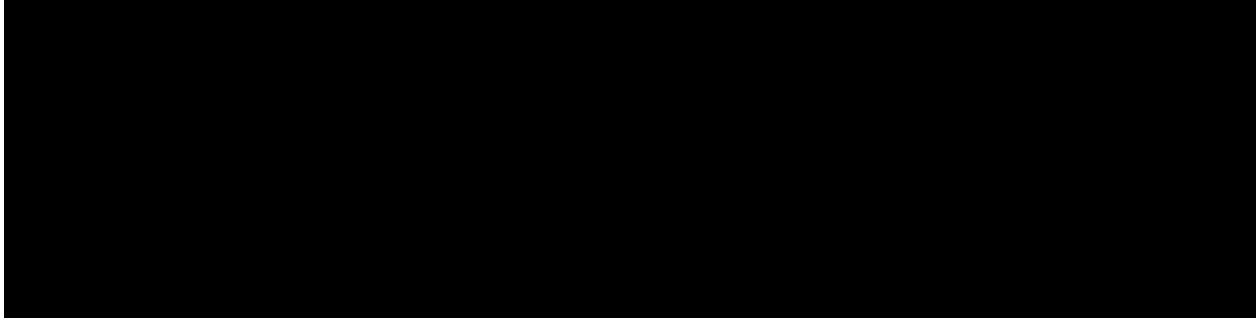

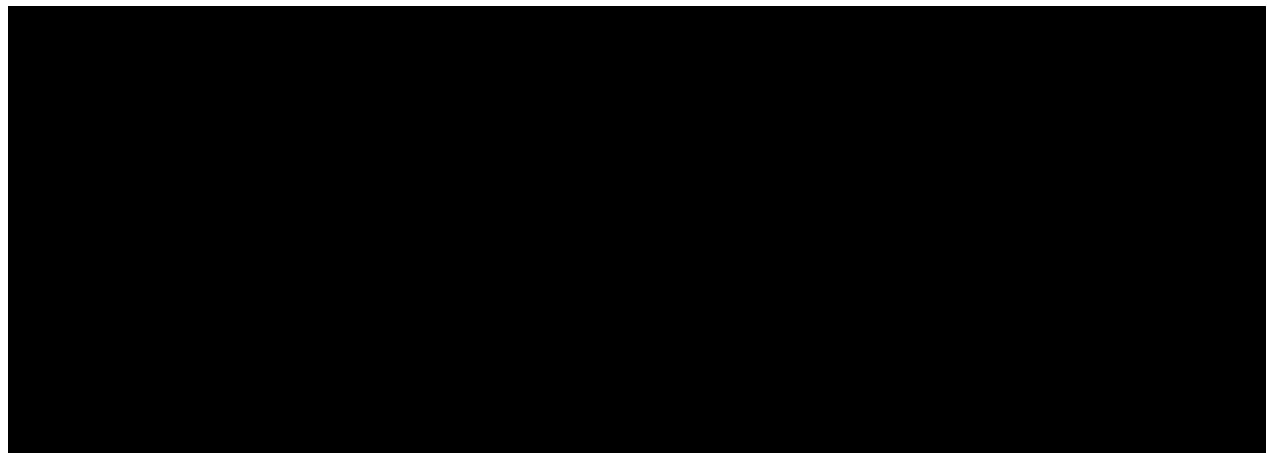

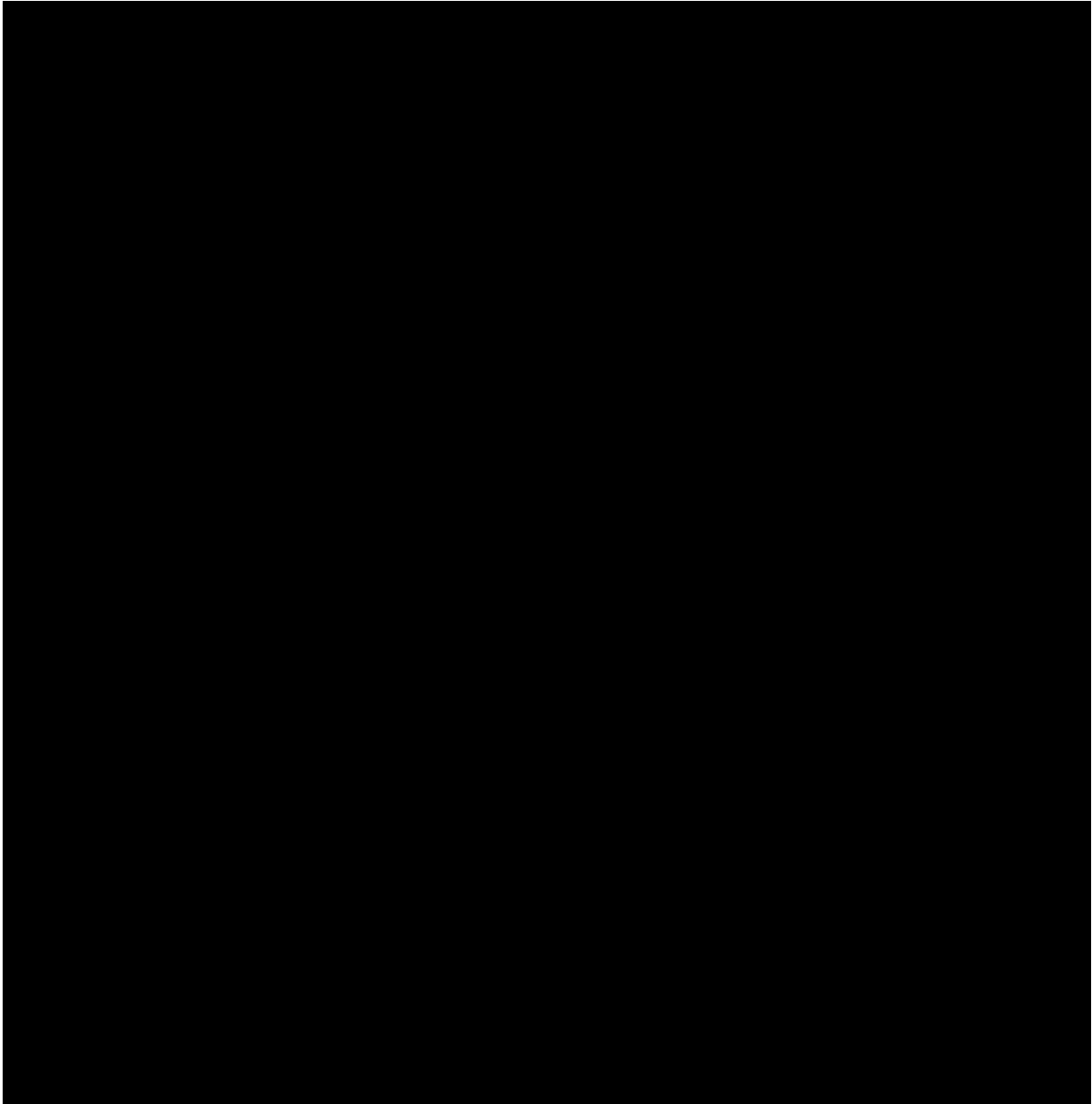

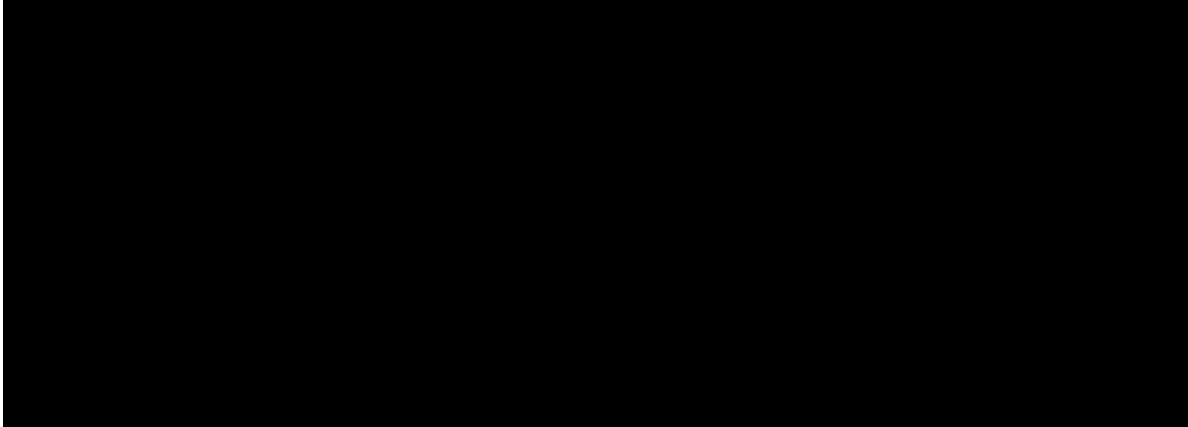

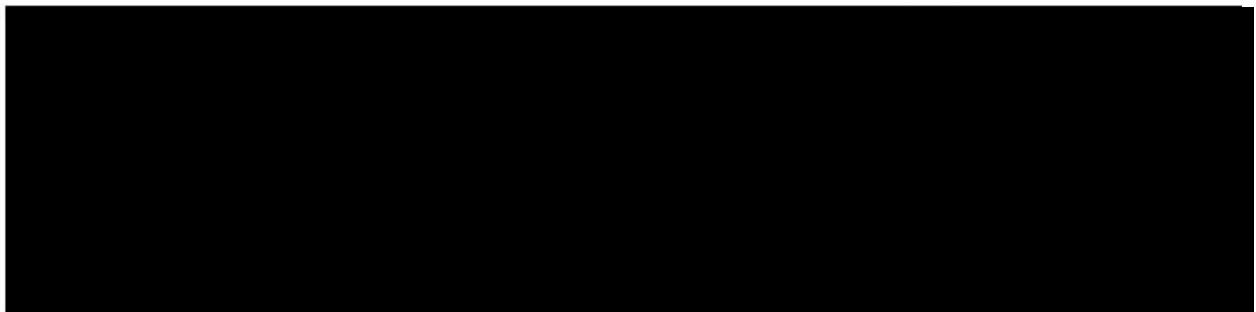

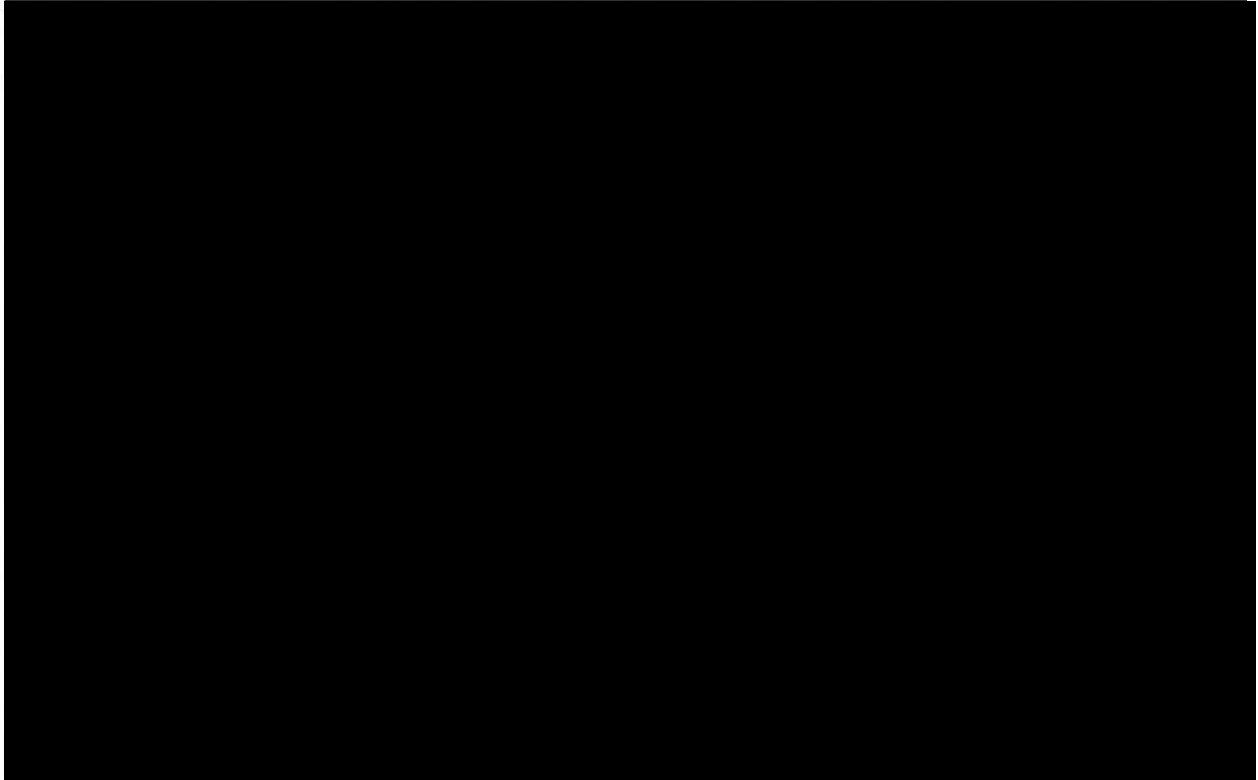
