On Tuesday, July 12, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Butterworth (SA Butterworth) received training records for Deputy ██████████ SA Butterworth reviewed the training records and noted the following:

Ohio Peace Officer Training Academy/Commission Records

SA Butterworth obtained the Ohio Peace Officer Training Commission (OPOTC) and Ohio Peace Officer Training Academy (OPOTA) records pertaining to Deputy ██████████ The POLARIS system utilized by OPOTA/OPOTC indicated the following:

1. Basic Training

Deputy ██████████ attended the Basic Peace Officer Training Academy at Clark State Community College from March 2011 to July 2011. Deputy ██████████ also attended the Franklin County Sheriff's Office Corrections Academy from January 2010 to February 2010.

2. Advanced Training

Deputy ██████████'s advanced training includes the following: Surveillance Operations, November 2018; Semi-Auto Pistol Instructor, and VALOR Training November 2014.

3. Employment History

Deputy ██████████'s employment history indicates that he has been employed with the Franklin County Sheriff's Office since November 22nd, 2011. This was the only agency listed in the employment records.

4. Update Training

Deputy ██████████ has completed CPT and required training in 2014, 2015, 2016, 2017 and completed Human Trafficking in April of 2017. Deputy ██████████ also completed Companion Animal Encounters in December of 2018.
