## DISAPPROVAL, BONDS OF THE CITY OF CAMPBELL, MAHONING COUNTY—\$2,500.00.

COLUMBUS, OHIO, March 19, 1928.

Re: Bonds of the City of Campbell, Mahoning County, \$2,500.00.

*Industrial Commission of Ohio, Columbus, Ohio.*

GENTLEMEN:—I have examined the transcript of the proceedings of the council and other officers of the City of Campbell, Mahoning County, Ohio, relative to the above bond issue, the purpose of which is to provide funds for the purchase of motor vehicles for the police department of the city.

Under date of February 28, 1928, I rendered an opinion to your Commission bearing No. 1777, disapproving the purchase of bonds of the above city in the sum of \$18,821.59. The reasons for disapproving the purchase of the bonds last above mentioned are set out in the opinion above referred to. A copy of that opinion is enclosed herewith.

The bonds now under consideration are of the same class as the bonds the purchase of which was disapproved in Opinion No. 1777, and the same reasons for disapproving those bonds apply to the present issue. The financial statement shows that bonds in the sum of \$9300.00 were retired between January 1st and January 31st, 1928, but the \$18,821.59 issue which has been issued and is outstanding, together with the \$2500.00 issue now under consideration, clearly is in excess of 90% of the amount of bonds retired during the present calendar year.

For the foregoing reasons and those stated in Opinion No. 1777 above referred to, the purchase of the above bonds is disapproved. I am returning the transcript to you herewith.

## APPROVAL, CONTRACT BETWEEN THE STATE OF OHIO AND THE CAPITOL PLUMBING AND HEATING COMPANY, COLUMBUS, OHIO, FOR THE CONSTRUCTION OF PLUMBING, HEATING AND VENTILATING FOR ADDITIONS TO COLUMBUS STATE HOSPITAL, COLUMBUS, OHIO, AT AN EXPENDITURE OF \$9,195.00—SURETY BOND EXECUTED BY THE GLOBE INDEMNITY COMPANY.

DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Department of Public Works, for the Department of Public Welfare, and The Capitol Plumbing and Heating Company, of Columbus, Ohio. This contract covers the construction and completion of combined plumbing and heating and ventilating contracts for additions to wards of Fourth Sections, North and South Wings of Main Building, Columbus State Hospital, Columbus, Ohio, and calls for an expenditure of nine thousand, one hundred and ninety-five dollars (\$9,195.00).

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract. You have also submitted a certificate from the Controlling Board, signed by the secretary thereof, that in accordance with Section 12 of House Bill No. 502, 87th General Assembly, said board has properly consented to and approved the expenditure of the monies appropriated by the 87th General Assembly for the purpose covered by this contract. In addition, you have submitted a contract bond upon which the Globe Indemnity Company appears as surety, sufficient to cover the amount of the contract.

You have further submitted evidence indicating that plans were properly prepared and approved, notice to bidders was properly given, bids tabulated as required by law and the contract duly awarded. Also it appears that the laws relating to the status of surety companies and the workmen's compensation have been complied with.

Finding said contract and bond in proper legal form, I have this day noted my approval thereon and return the same herewith to you, together with all other data submitted in this connection.
