### Narrative:

On Monday, April 19, 2021, the Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Kevin Barbeau sent the attached subpoena, via fax, to Westerville Division of Fire (WFD), attention Chief Mindy Gabriel. The purpose of the subpoena is to obtain records pertaining to Miles Jackson, who was transported to St. Ann's Hospital (500 South Cleveland Ave, Westerville, Ohio) on Monday, April 12, 2021. Jackson was later involved in an Officer-Involved Critical Incident (OICI), which occurred at St. Ann's Hospital on this date. BCI learned Columbus Police officers were taking Jackson (involved subject) into custody at St. Ann's Hospital Emergency Department (ED) room. A struggle ensued and CPD officers and St. Ann's (armed) Security Officers discharged their duty weapons. Miles died from apparent gunshot wounds.

Prior to the shooting incident WFD (EMS) and Westerville Police Department (WPD) made contact with Jackson, unknown location. Jackson was said to be assessed by EMS and then transported to St. Ann's. BCI is requesting the records from this contact.
