On 06-14-2021, at approximately 0035hours, Officer G. Ivory responded to a shots fired incident that had occurred at 401 W. Liberty Street. Officer G. Ivory spoke with the reporting person, Buffy J. Gilbert, who stated that the listed suspect, an unknown male, had pointed a handgun at her two children CV1 and CV2. Ms. Gilbert stated that she yelled at the male and he fled the scene. A short time later, the male had returned and fired several rounds from a "big gun". Officer G. Ivory located several spent shell casings in the street to the east of the residence. A teal 2010 Chrysler Town & Country van, Ohio license plate # HLW 9134 was struck by at least 1 round causing damage to the windshield and headrest of the vehicle. Members of the Springfield Police Crime Scene Unit responded to the scene and collected these items. Members of Crime Scene Unit also photographed the scene. All of the property collected at the scene and the photographs were later submitted into evidence by members of the Crime Scene Unit.

After follow up investigation of the initial report which was made on 06-14-21, it was found that during the shots fired in the direction of 401 W. Liberty St., and vehicles that were parked at the curb, that Victim (Larry C. Gilbert), and victim (Robert E. Gilbert III) were both outside and the shots were fired in their direction. Both stated they were outside standing to the east of the residence at 401 W. Liberty St. where victim (Larry C. Gilbert) resides with his family when dark Trailblazer pulled over to the curb on S. Plum St. directly across from them. Both stated the suspect (known as TR) then began yelling "why did you call the police on me", and at some point began waving a handgun, and then discharged the firearm in their direction multiple times. Both stated they took cover behind the vehicles, and at some point victim (Larry C. Gilbert) was grazed in the right lower leg, at which time victim (Larry C. Gilbert) raised up and discharged a handgun in the direction of the suspect vehicle which fled the scene (see case #21-24738). The victims were both interviewed on 06-21-21, and both identified the suspect (Eric E. Cole) known as "TR" in a photo array, and stated he was the shooter that night. Detectives were also able to acquire video from a ring door bell system in the area, which shows shots being fired from the suspect vehicle parked at the curb on S. Plum St.
