Narrative:

On November 7, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent Kyle Douglass (SA Douglass) met with Fraternal Order of Police (FOP) legal counsel Jess Franken (Franken) for interviews with witness officers from Cambridge Police Department (CPD) regarding an Officer Involved Critical Incident (OICI) which occurred on June 15, 2023.

Franken, as FOP legal representative of CPD [REDACTED] [REDACTED] [REDACTED] who was involved in the OICI, reported [REDACTED] did not intend to provide a statement to BCI regarding his involvement in the incident on June 15, 2023.

On January 3, 2023, SA Douglass received confirmation via email from Franken stating [REDACTED] did not wish to provide a verbal or written statement to BCI regarding his involvement in the OICI which occurred at 428 Foster Avenue in Cambridge on June 15, 2023.
