APPROVAL—LEASE EXECUTED BY THE STATE OF OHIO
COVERING SEVERAL PARCELS OF RESERVOIR LANDS
AT BUCKEYE LAKE, OHIO.

DEAR SIR: You recently submitted for my examination and approval a number of reservoir land leases executed by you as Conservation Commissioner to the several leasees therein named, by which there were leased and demised to the respective lessees therein named a number of parcels of reservoir lands owned by the state at Buckeye Lake, Ohio.

These leases, designated as to the names of the several lessees, the locations of the parcels of land leased, and the annual rental provided for therein, are as follows:
