## Narrative:

On Tuesday, November 12, 2024, Special Agent Dan Boerner (SA Boerner) attended the autopsy of Charles Ryan Alexander (Alexander). The autopsy took place at the Cuyahoga County Medical Examiner's Office (11001 Cedar Ave., Cleveland, Ohio 44106, OU2024-00436). The autopsy was conducted by Dr. Kara Gawelek (kgawelek@cuyahogacounty.us). During the autopsy significant trauma was observed to the left side of Alexander's head visually consistent with a gunshot wound. No additional suspected gunshot wounds were observed on Alexander.

On Thursday, November 14, 2024, SA Boerner received seventeen (17) items of evidence collected during the autopsy of Alexander from the Cuyahoga County Regional Forensic Science Laboratory (CCRFL) and transported the items to the BCI Office in Richfield. The items of evidence were subsequently placed into temporary evidence cabinet 40.
