This contract covers the construction and completion of Contract for General Work for a project known as Extension to Main Building and Service Lines, Columbus State Hospital, Columbus, Ohio, in accordance with Item No. 1 of the form of proposal dated July 31, 1935. Said contract calls for an expenditure of ninety-five thousand four hundred and eighty-eight dollars (\$95,488.00).

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract.
