Narrative:

On June 15, 2023, the Ohio Bureau of Criminal Investigation (BCI) was requested by Cambridge Police Department (CPD) for assistance in reference to an Officer-Involved Critical Incident (OICI). It was reported by CPD that during a domestic disturbance call at 428 Foster Avenue in Cambridge, Taurean Brown (Brown) allegedly fired a weapon at responding officers and a CPD officer had returned fire. CPD further reported Brown had barricaded himself inside the residence and was in a stand-off with officers and multiple SWAT teams that had surrounded the home. BCI Crime Scene Unit (CSU) agents arrived while the scene was still active with SWAT officers attempting to call Brown out of the residence. Officers from the Ohio State Highway Patrol (OSP) Special Response Team (SRT) were requested by CPD to assist with the barricade situation. OSP SRT deployed a drone into the residence and Brown was discovered in the upstairs hallway deceased, with several firearms in his vicinity.

Officers from multiple agencies responded to the incident including CPD, OSP, Guernsey County Sheriff's Office (GCSO), Muskingum County Sheriff's Office (MCSO), and Byesville Police Department (BPD). BCI requested written statements from these agencies for officers who responded to the incident at 428 Foster Avenue.

On August 24, 2023, BCI Special Agent Kyle Douglass (SA Douglass) received copies of responding officers' written statements from OSP Sergeant Mason Boyce. Written statements were received for the following OSP responders:

to locate the suspect. We approached the same side 2 window a second time 11:47pm to throw a recon robot into the second story window. At midnight, Bumgardner was able to fly a drone into the second story side 2 window and locate the suspect lying in the hallway, on the second story. The suspect was not moving and appeared to have sustained a self inflicted gunshot wound to the head. Shortly thereafter Cambridge SWAT made entry into the residence and confirmed what the drone had discovered. OSHP SRT accounted for all of its equipment and departed from the scene to conduct a debrief at the OSHP Cambridge Post.

On June 15th, 2023 at around 1821 hours I received a call to respond to Cambridge for an armed barricaded subject that shot at police officers. I was asked to bring BEAR 2, our armed vehicle to the scene. Once I arrived on scene I parked the BEAR at the side ¼ corner of the structure and gave armored cover to the law enforcement at that corner. During the operation I deployed less lethal rounds to break a total of three windows on side one and four. I then deployed CS and OC flameless gas rounds into the structure. Approximately one hour later, I flew a BRINC drone into the structure to try and locate the suspect without success in finding him. Shortly after that, I was informed the suspect was located and told to head to the Cambridge District Headquarters for debrief.

On June 15, 2023 at approximately 1840hrs, I was notified by my direct supervisor, Sgt Mason Boyce, of a barricade situation invloving an armed individual at 428 Foster Ave, Cambridge, Ohio. I responded from my residence in my marker patrol vehicle SP 1570.

I arrived on scene at approximately 1948hrs. I parked my patrol vehicle several blocks from the scene, took my rifle, and my ballistic helmet from the vehicle, and walked to the scene. I met with my supervisors on the scene and was briefed on the situation. I was instructed to take up a containment position on the 2/3 corner of the residence. Around 2050hrs, Tpr Andre Thomas and I moved to our position. There were two Muskingum County Sheriff's deputies holding containment on the 2/3 corner behind a marker Sheriff's Cruiser at that location. We linked up with them to assist. I was tasked with holding the ballistic shield from that spot. The Deputies were utilizing their rifles to hold lethal cover on the residence. We were instructed to attempt to break the window on the 2 side second story of the residence. The window was the one closest to the rear of the house. Tpr Thomas, a Msukingum County Deputy, and I moved from behind the cover of the cruiser and into position from behind a tree. Tpr Thomas was using a rotary launcher, I was on shield, and the deputy was providing lethal cover for us. From that position Tpr Thomas fired wood baton rounds into the window at approximately 2140hrs and broke out the window. We then retreated back to the cover of the cruiser. The three of us then returned to the tree position around 2200hrs and introduced gas into the structure through the window Tpr Thomas had previous broke out. The three of our job duties remained the same. After depolying the gas, we again retreated to the patrol vehicle cover.

I remained at the 2/3 corner until I was instructed to move to the 3/4 corner to assist on containment on that side. There I met up with two other deputies and remained there for the remainder of the incident until we were notified the suspect was observed by another officer on scene via a drone camera. It was relayed the suspect appeared to be deceased from a gunshot wound and was lying on the floor. I then moved from my position back to the 2/3 corner where I remained until the entire structure had been cleared by a local team and verified the subject was deceased. I cleared the scene at approximetly 0041Hrs.
