I am therefore of the opinion, in specific answer to your question that boards of education are not empowered by law to expend public school funds under their control for the furnishing of food for undernourished children or clothing, such as sleeping garments and the like, for any of the pupils attending the schools of their district, whether or not these pupils are in attendance in special schools for tubercular children established under the provisions of Section 7644-1, General Code.
