Narrative:

On Monday, April 12, 2021, at approximately 1835 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Jim Mulford (SA Mulford) interviewed Miranda Rosebrook (Rosebrook) in response to an Officer Involved Critical Incident (OICI) that occurred earlier this date at Mount Carmel St. Ann's Hospital in Westerville, OH. An altercation happened between Miles Jackson (Jackson) and officers from the Columbus Division of Police, Westerville Police, and St. Ann's Security Department. Jackson died as a result of gunshot wounds from this incident. The purpose of the interview was to obtain all relevant information of the incident known or observed by this individual.

This interview was audio recorded, and a copy of the recording was saved electronically within the case file. Please refer to the recording for specific quotes. The following is a summation of the interview:

Rosebrook explained she is a registered nurse at St. Ann's. She was scheduled to work from 1000 hours to 2200 hours this date.

Rosebrook "checked" Jackson into the hospital and completed his initial assessment during his second admittance of the day. She was aware he was at the hospital earlier that morning and had left against medical advice (AMA). Rosebrook believed it had only been approximately 1.5 hours since he left the hospital that EMS brought him back to the hospital based on complaints of acting confused and public in showing symptoms of a drug overdose. According to Rosebrook, EMS personnel administered Narcan to Jackson during the transport. When he arrived at the hospital he was alert and understood he had been in the hospital earlier that day. Jackson was calm and cooperative with Rosebrook and denied any thoughts of homicidal or suicidal actions.

A few hours later, Rosebrook heard commotion coming from room number nine. She started walking towards the room and heard police officers yelling, "Stop resisting. Stop resisting." Rosebrook then heard the sound of a taser and moments later she heard gunshots.

Rosebrook ran and hid inside of a stockroom with other medical personnel. She remained in this area until after the incident. During the altercation she heard the officers giving several commands and then heard lots of gunshots.

SA Mulford asked Rosebrook if she could remember what clothing Jackson was wearing when she checked him into the hospital. Rosebrook recalled seeing Jackson wearing a white t-shirt, red sweat pants, a grey sweatshirt tied around his waist, and a red toboggan hat. She was unaware if Jackson had any other personal property with him.

Throughout the day, Rosebrook walked past Jackson's room numerous times. He seemed to be cooperative with the medical personnel and the police officers that were standing outside of his room.

Rosebrook said she was not Jackson's primary nurse. She only checked Jackson in because his primary was busy at the time. Nurse Laura Webb would've been his primary nurse with him during both visits.

Rosebrook confirmed she did not see any of the actual shooting incident and only heard parts of it. She had no further information. The interview concluded.
