Narrative:

On May 3, 2024, at about 0916 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Chuck Moran (Moran) met with Tuscarawas County Sheriff's Office (TCSO) was identified as the deputy involved in the incident.

told SAS Moran that he did not want to provide a statement to BCI at that time. Indicated that he was not physically injured during the incident. SAS Moran provided **Constant of** with a business card and told him to have his legal counsel with the Fraternal Order of Police contact BCI to schedule a potential interview or statement.

SAS Moran obtained four photographs of **Sector Constants** in his TCSO uniform that he was wearing during the incident.

s duty pistol was already unloaded when SAS Moran arrived at the TCSO. Captain Travis Stocker (Stocker) indicated that he assisted **Stocker** with unloading the pistol. Captain Stocker told SAS Moran which cartridge was in the chamber of the pistol when it was unloaded. There were eight 9mm cartridges remaining in total. **Stocker** believed his pistol was fully loaded with 17 cartridges in the magazine and one cartridge in the chamber (18 cartridges total).



The pistol was later turned over to Special Agent Joe Goudy for transport to BCI. A copy of the evidence receipt is attached to this report.
