Narrative:

On Monday, May 06, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) received video footage from Captain Adam Fisher (Fisher) of the Tuscarawas County Sheriff's Office (TCSO) and Sergeant Shawn Allar (Allar) of the Ohio State Highway Patrol (OSHP). The footage was from the dash cameras recorded by the TCSO, OSHP and the Dover Fire Department (DFD) Emergency Medical Service (EMS).

On Tuesday, July 30, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jesse Bynum (Bynum) reviewed the video recordings and noted the following:

The subfolders for both “event” and “park” folders were all empty. The “photo” folder contained images from the beginning of each of the videos. The “version” folder was empty. The “video” folder contained the following amounts of items in the subfolders described below. The subfolder labels were determined to denote the position of the camera for example camera D is focused on the ambulance driver. Camera F is focused outside of the ambulance facing the front. Camera M was focused on the passenger seat of the ambulance. Lastly the subfolder R was found to be empty.
