**Narrative:**

On Tuesday, September 9, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Lamping (Lamping) received requested records and recordings from Ashtabula County Sheriff's Office (ACSO). SA Lamping had previously requested all dispatch records, audio recordings (radio, 911, and phone), and any other dispatch/communications-related information regarding the officer involved critical incident (OICI). As a result of that request, the following items were received and reviewed:

Radio Traffic Recordings:

The ACSO radio traffic Report documents times personnel were assigned to the call. The report contains the dispatch, en route/arrival times of the officers who responded, with the call type being Suspicious Activity. The radio traffic Report can be located in Axon Justice - Reference Item F. The recording in its entirety is 39 minutes and 29 seconds long.
