DEAR SIR: You have submitted for my examination and approval certain lease, No. 2411, executed to the State of Ohio by one Bertha E. Ferris of Oregonia, Warren County, Ohio, leasing and demising to the

state for the purpose therein stated a tract of land in Washington Township, Warren County, Ohio.

This lease is for a term of two (2) years, and the property described is leased to the state for the sole purpose of a state public archery hunting ground. And, in this connection, it is noted that the Conservation Council, acting through you as Conservation Commissioner, has made an order setting aside the lands described in the lease for the purpose of a state public archery hunting ground, as provided for in Section 1435-1, General Code.

Upon examination of this lease, I find that the same has been executed and acknowledged by the lessor in the manner provided by law. I also find upon examination of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with statutory provisions relating to the execution of leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate copy thereof, which are herewith returned.
