On December 12, 2022, Special Agent John Rodriguez responded to the High Meadows Subdivision in Powell, Ohio to assist with the investigation of an Officer-Involved Critical Incident (shooting). Special Agent John Rodriguez was assigned to make contact with residents in the area.

At 2330 hours, Special Agent John Rodriguez made contact with Vyacheslav Zalygayev and Aleksnder Kaleta at their residence located at 667 Slate Hollow Ct., Powell, Ohio.

Both Vyacheslav Zalygayev and Aleksnder Kaleta reported the following:

Vyacheslav Zalygayev and Aleksnder Kaleta were at home during the event. Vyacheslav Zalygayev reported he was the owner of 677 Slate Hollow Ct., and was showing the residence to a possible renter. After showing the residence, Vyacheslav Zalygayev went to his residence a couple doors down located at 667 Slate Hollow Ct. Upon entering residence, Vyacheslav Zalygayev heard gunshots ring out and coming from inside of Sean and Kelly Hinton's residence. Vyacheslav Zalygayev witnessed sheriff's deputies outside of Sean and Kelly Hinton's residence before hearing the gunshots.

Vyacheslav Zalygayev and Aleksnder Kaleta both knew Sean and Kelly Hinton well and often spoke to them. Vyacheslav Zalygayev and Aleksnder Kaleta reported they had not had much contact with Kelly and Sean Hinton and not seen or spoke with them since Thanksgiving. Kaleta reported Kelly Hinton would often complain about Sean Hinton drinking and she often complained about their financial situation as well. Kelly Hinton would often talk about going back to school and becoming more independent. Kelly Hinton also told Aleksnder Kaleta she was planning on leaving Sean Hinton at some point.

During this interview Special Agent Rodriguez noticed the residence was equipped with a Ring doorbell and inquired if the device was currently active. Vyacheslav Zalygayev reported the device was currently active and more than likely recorded the event that had taken place just a couple

doors down from his residence. Vyacheslav Zalygayev reported the life span of the recording is short, but he would be able to download and provide the recording of the event upon request.

It is suggested that the full audio recording be reviewed to clarify any content or contextual questions regarding the information from the interview.
