)	STATE'S MOTION FOR APPOINTMENT OF SPECIAL PROSECUTOR

Now comes the State of Ohio, by and through Michael C. O'Malley, the Prosecuting Attorney for Cuyahoga County, Ohio and his assistant, Lisa Reitz Williamson and hereby applies to this Honorable Court for the appointment of Ohio Attorney General Dave Yost, or any of his designees, assistants or deputies, as special prosecutor to investigate and prosecute matters involving an alleged Use of Deadly Force ("UDF") investigation originating in the City of East Cleveland in Cuyahoga County, Ohio on January 5, 2021.

Special prosecutors may be appointed by the Common Pleas Court in accordance with Revised Code Sections §309.10. Moreover, the Court, under its inherent power, may appoint a special prosecutor whenever it comes to the Court's attention that the ability to administer justice in a fair and impartial manner could be called into question. Such a case exists when there is a conflict or appearance of conflict of interest between the parties. Where a special prosecutor has been appointed under the Court's inherent power, that special prosecutor acts independently of the duly elected prosecutor. The Cuyahoga County Prosecutor's Office has adopted a policy that requires an independent

prosecutor to prosecute any allegation of police-related use of unlawful deadly force that results in a death. This policy was developed to ensure that there is no conflict or appearance of conflict of interest between the Cuyahoga County Prosecutor's Office and the various police departments within Cuyahoga County, Ohio.

Wherefore, the Prosecuting Attorney respectfully requests this Honorable Court exercise its authority and appoint Ohio Attorney General Dave Yost, or any of his designees, assistants or deputies, as special prosecutor to prosecute the matter involving the alleged use of deadly force investigation that occurred on January 5, 2021 in the City of East Cleveland. Should this Court sign said order, upon the signing of the order appointing Ohio Attorney General Dave Yost, or any of his designees, a copy of said order will be provided to the investigating agency to ensure that investigative materials are provided directly to Ohio Attorney General Dave Yost. Wherefore, Ohio Attorney General Dave Yost is hereby appointed to represent the State with the same power and authority granted by law to the Cuyahoga County Prosecutor and may utilize the support services of the Cuyahoga County Prosecutor's Office.
