Narrative:

On June 15, 2023, the Ohio Bureau of Criminal Investigation (BCI) was notified by the Cambridge Police Department (CPD) of an Officer-Involved Critical Incident at 428 Foster Avenue in Cambridge, OH. It was initially reported shots were fired by CPD SWAT officers at this location and an involved party was deceased.

Upon arrival, BCI Special Agent Kyle Douglass (SA Douglass) was notified CPD was responding to a call of domestic violence when they became involved in an encounter with Taurean Brown (Brown). During the encounter, a standoff between CPD and Brown ensued, and a CPD SWAT officer discharged their firearm. Brown was located several hours later inside the residence with an apparent gunshot wound, and was pronounced deceased on scene. No CPD officers were injured during this incident. Officers from the Guernsey County Sheriff's Office (GCSO), Muskingum County Sheriff's Office (MCSO), Byesville Police Department (BPD), and Ohio State Highway Patrol (OSP) were also on scene during the incident.

BCI agreed to investigate the OICI. SA Douglass was assigned Special Investigations Unit (SIU) lead special agent, and BCI Special Agent Shawn Rowley (SA Rowley) was assigned as the lead Crime Scene Unit (CSU) special agent.

After the scene was photographed and processed by CSU, SA Rowley and SA Douglass conducted a scene walkthrough.
