Investigative Activity: Body-Worn Camera Review Authoring Agent: Special Agent Cory Momchilov #64

Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Cory Momchilov (Momchilov) was provided a total of 50 body-worn camera footage clips from 44 different Akron Police officers.

A total of 12 body-worn camera footage clips captured portions of the shooting.

The body-worn camera footage from the officers (8 clips) who discharged their weapons, as well as body-worn camera footage from four witness officers whose body-worn camera captured portions of the shooting, was sent to the Ohio Organized Crime Investigation Commission (OOCIC) for further analysis.

It should be noted that the AXON body-worn cameras worn by the Akron Police officers are equipped with "Buffering mode." In Buffering mode, when an officer activates his body-worn camera, the camera captures events 30 seconds in the past. However, the 30 seconds does not contain audio.

SA Momchilov reviewed all body-worn camera footage and noted the follow:

Approximately 3 minutes and 46 seconds into the footage, Officer broadcasts, "Alright we got one, we got 2 units in front of us."
