Narrative:

On Friday, September 26, 2025, at approximately 1129 hours, Ohio Bureau of Criminal Investigation (BCI) Administrative Professional (AP) Betsy Turney (Turney) met with Ashtabula County Sheriff Office (ACSO) Detective Jonelle Gerke (Det. Gerke) at BCI Richfield to release an evidence item. Special Agent (SA) Joe Lamping (SA Lamping) had previously obtained permission from Ashtabula County Prosecutor April Grabman to release a flashlight (Matrix Item 41) which belongs to ACSO [REDACTED]. The flashlight had been dropped by [REDACTED] on scene and collected as evidence. However, the flashlight was discovered to have no relevance to the investigation. Det. Gerke took possession of [REDACTED] flashlight and signed an evidence transfer receipt, which was attached to this report.
