## Narrative:

On December 31, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Tiffany Najmulski. (SA Najmulski) received requested records and recordings from Celina Police Department Chief Thomas Wale (Chief Wale). SA Najmulski had previously requested all dispatch records, audio recordings (radio, 911, and phone), mobile data terminal (MDT) communications, and any other dispatch/communications-related information for the following date and time period: December 31, 2024, at approximately 0251 hours. As a result of that request, the following items were received and reviewed:

# Computer Aided Dispatch (CAD) Records:

# Radio Traffic Recordings:

At 2:53:31AM dispatch radioed for units to head to the Marathon Station on Main Street in reference to a man attempting to jump into the complainant's car. The subject was last seen heading west on Warren Street.

At 3:00:39 AM Officers dispatched they observed a Marshallese male behind the Marathon Station, wearing yellow shoes, blue pants, and a brown or purple colored puffer coat, holding a "40A" to his neck.

At 3:02:48 AM An officer radioed, "Shots fired! Shots fired!"

At 3:04:40 AM An officer asked if a squad was in route and dispatch radioed, "Affirm".

## 911 Calls:

The first call came in on 12/31/2024 at 0251 hours by the name of Erinn Johnson (Johnson) with the phone number of When dispatch picked up, Johnson could be heard

telling someone, "I'm about to beat your ass". Johnson proceeded to tell dispatch he is at the Marathon station on S. Main Street. He said some guy with short hair, a puffer coat and blue jeans just hopped in his car, a 2004 Toyota Echo, trying to steal it. Johnson further stated the unknown person whom he described as possible Hispanic, was now walking somewhere around the gas station and that the man was not in his right mind. According to Johnson, the man told Johnson some guys were chasing him and if Johnson smoked he would see them as well. The dispatcher then dispatched units to that location.


