APPROVAL—TWO RESERVOIR LAND LEASES, STATE OF OHIO, THROUGH CONSERVATION COMMISSIONER, DESIGNATED LANDS, BUCKEYE LAKE, FAIRFIELD COUNTY, OHIO, ANNUAL RENTAL BASIS, WITH MRS. NELLIE LOEWER, \$18.00 AND ANNA C. HESSENAUER, \$15.00, TERM FIFTEEN YEARS.

DEAR SIR: You recently submitted for my examination and approval two reservoir land leases executed by you as Conservation Commissioner to the lessees therein named, by which there were leased and demised to the respective lessees therein named, parcels of reservoir lands owned by the State at Buckeye Lake, Ohio.

These leases, designated as to the names of the lessees, and the annual rental provided for therein, are as follows:
