**Narrative:**

On May 20, 2024, Special Agent (SA) Josh Rammel (Rammel) completed the review of all CAD reports provided by the Tuscarawas County Sheriff's Office (TCSO) regarding the Officer Involved Critical Incident (OICI) associated with involved individual Matthew Flynn (Flynn) and involved officer ██████████ ██████████ (██████████) which took place at 100 Block 9th Street, N.E. New Philadelphia, Ohio.

The CAD report indicated a call time of 21:06:06 on March 31, 2024, and a completed time of 03:49:18 on April 1, 2024.

The information listed below is only what is deemed most important to the investigation. The CAD log is attached to this investigation. See the attachment for the complete details. The title "suspect" is used in the information listed below solely for the reason that the wording was used in the CAD transcripts.

1. At 21:06:49 on 03/31/2024 the report indicated that a car wrecked into a house located at 827 East High Avenue and an individual was seen walking and then running down Ashwood Lane and in an alley.
2. Multiple TCSO units were listed as being en route to the scene. At 21:07:55 on 03/31/2024, unit number ██████████ (██████████) advised he was en route as well.
3. At 21:09:49 on 03/31/2024, ██████████ is yelling on the radio, but it was listed as "unable to copy".
4. At 21:10:04 on 03/31/2024, ██████████ advised "shots fired".
5. At 21:10:12 on 03/31/2024, it was listed that the "suspect" took ██████████'s cruiser.
6. At 21:10:49 on 03/31/2024, ██████████ advised that additional shots were fired, and that

██████████ was struck on his finger.

7. At 21:11:25 on 03/31/2024, it was mentioned that the "suspect" was hit, but unsure where.

8. At 21:14:18 on 03/31/2024, it was stated that the driver was out of the vehicle, and at 21:14:18 the driver was listed as being unconscious.

9. At 21:16:15 on 03/31/2024, medics administered first aid to "suspect".

10. At 21:18:11 on 03/31/2024, an additional ambulance was called for ██████████

11. At 21:20:17 on 03/31/2024, Union Emergency Room was notified regarding the transport of a "30ish year-old male" with trauma from a shooting.

12. At 21:26:03 on 03/31/2024, Flynn was identified as the involved individual.

13. At 21:30:45 on 03/31/2024, ██████████ was transported to Aultman, request was made to notify wife.

14. At 21:49:19 on 03/31/2024, The Ohio Bureau of Criminal Investigation (BCI) was notified about the shooting.

Additional radio traffic was also observed including radio traffic not related to the OICI.
