

I am extremely concerned over the actions of the Akron OH police department lately. The Jayland Walker case hits pretty close my to home. I once worked in Montrose and frequent the Akron area for goods and services. Particularly, at this time, taking my Autistic child to appointments at Akron Childrens Hospital main campus down town Akron. I have seen the Akron police in riot gear physically attacking and menacing members of the press as well as Jayland Walker's family members. I seen that 2 teenage girls who live in the area on cerfew were trapped hiding in a parking garage for hours just trying to get home, and when they thought it could be safe to try to get home they were tear gassed and arrested. How is any of that okay? Why is this allowed to go on with no recourse to this police department? Silence from you're office is complicity. I am terrified to take my child to her dentist appointment at Akron Children's this Friday July 8th 2022. I am scared I could make a wrong turn somewhere and be assaulted by rogue police along with my child who is autistic like I said and reacts differently than others would to stressful situations. I thought we were better than this in Ohio.

How would they like the AG to help?

I want to see the officers who murdered Jayland Walker arrested and prosecuted to the fullest extent as soon as possible. I want to feel safe in the communities I have to frequent in Ohio. This is grotesque and inhumane. Reign this department in and stop the madness right now. Please! Do something about this now. We as citizens should not live in fear of our community protectors. I want harmony in our communities. It is especially important for my who has a child who cannot control their impulses and reactions.




