Victim #1 had on the CMHA uniform of the day on which consisted of a dark blue short sleeve shirt with CMHA police patches on both shoulders. The victim had on dark blue work pants and black work boots.

CONNER stated the suspect has mental health issues and is a crack cocaine addict.

CONNER stated this is why she and the suspect did not live together. CONNER stated that drugs are rampant at the apartment building where the suspect lived.

CONNER became hysterical and was hyperventilating during our notification regarding the suspect.

We notified EMS to respond. EMS #31 conveyed CONNER to St. Vincent Hospital for treatment.
