Narrative:

On June 14, 2021, Ohio Bureau of Criminal Investigation (BCI) Special Agent(s) Arvin Clar and John Tingley conducted a neighborhood canvass of South Park Blvd., regarding the officer-involved incident that occurred at 5714 South Park Blvd. earlier in the morning.

5703 South Park Blvd.

Danielle Walling (Walling) [440-479-6533] reported that she and her husband were inside their house and "did not see the incident." Walling did say they knew the subject, Kevin Giesel (Giesel), and he appeared in the past to be "agitated."

5715 South Park Blvd.

Sean Bruce (216-702-9949) reported that he was not home during the incident.

5702 South Park Blvd.

Joe Ziats (440-845-6198) reported that he was upstairs in bed (in the house) when he heard the following:

- 0200 hours Heard one shot
- 0230 hours Heard two shots
- 0245 hours Heard one shot
- 0300 hours Heard three shots

5694 South Park Blvd.

Amanda Wilberger (Wilberger) [216-645-6130] reported that she did not observe any activity but did hear what she describes as "boom boom" at 0230 hours.

Wilberger also said that she could hear the police say, "Kevin answer your phone," and, "Kevin come out with your hands up."

Wilberger reported that she knows Giesel as the "crazy kinda drunk fireworks guy."

5715 South Park Blvd.

Sean Bruce (Bruce) reported that he was not home during the incident. Bruce also reported he does not have video recording on the outside of his home.

5720 South Park Blvd.

Aubrey Hardy reported that prior to the officer-involved incident, she left the area and did not return home until 0800 hours on June 14, 2021.

5729 South Park Blvd.

Steve Coso (Coso) reported that he did not observe any of the police activity. Coso did report that he heard "2 bangs" during the course of the event.

5734 South Park Blvd.

John Steiber reported that he left his residence about 1530 hours on June 13, 2021, and did not return until the following morning at approximately 0700 hrs.
