**Narrative:**

On Tuesday, October 14, 2025, at the request of Assistant Prosecuting Attorney Erin Leigh Claypoole, Montgomery County Prosecutor's Office, Bureau of Criminal Investigation Special Agent Supervisor Kevin Barbeau arrived at Blendon Township Police Department (BLTP) to take pictures of the vehicle associated with this Officer-Involved Critical Incident (shooting). It should be noted that Assistant Prosecutor Claypoole is prosecuting said investigation within Franklin County as a special prosecutor appointed by Franklin County.

Upon arrival at BTPD, SAS Barbeau was met by BTPD Attorney Thomas N. Spyker (Reminger Co., LPA) and Lieutenant Josh Retherford (Lt. Retherford). They escorted SAS Barbeau to an unattached building behind BTPD. Once inside, Lt. Retherford gained access to a caged in area where the vehicle was being stored. The cage surrounded the vehicle and was secured with locks and zip ties. Once opened, SAS Barbeau took the attached pictures. SAS Barbeau did not enter the vehicle and the pictures were taken while standing outside the vehicle.

Once the photographs were taken, Lt. Retherford secured the cage in the same manner.

These photographs were sent, via e-mail, the Assistant Prosecutor Claypoole.

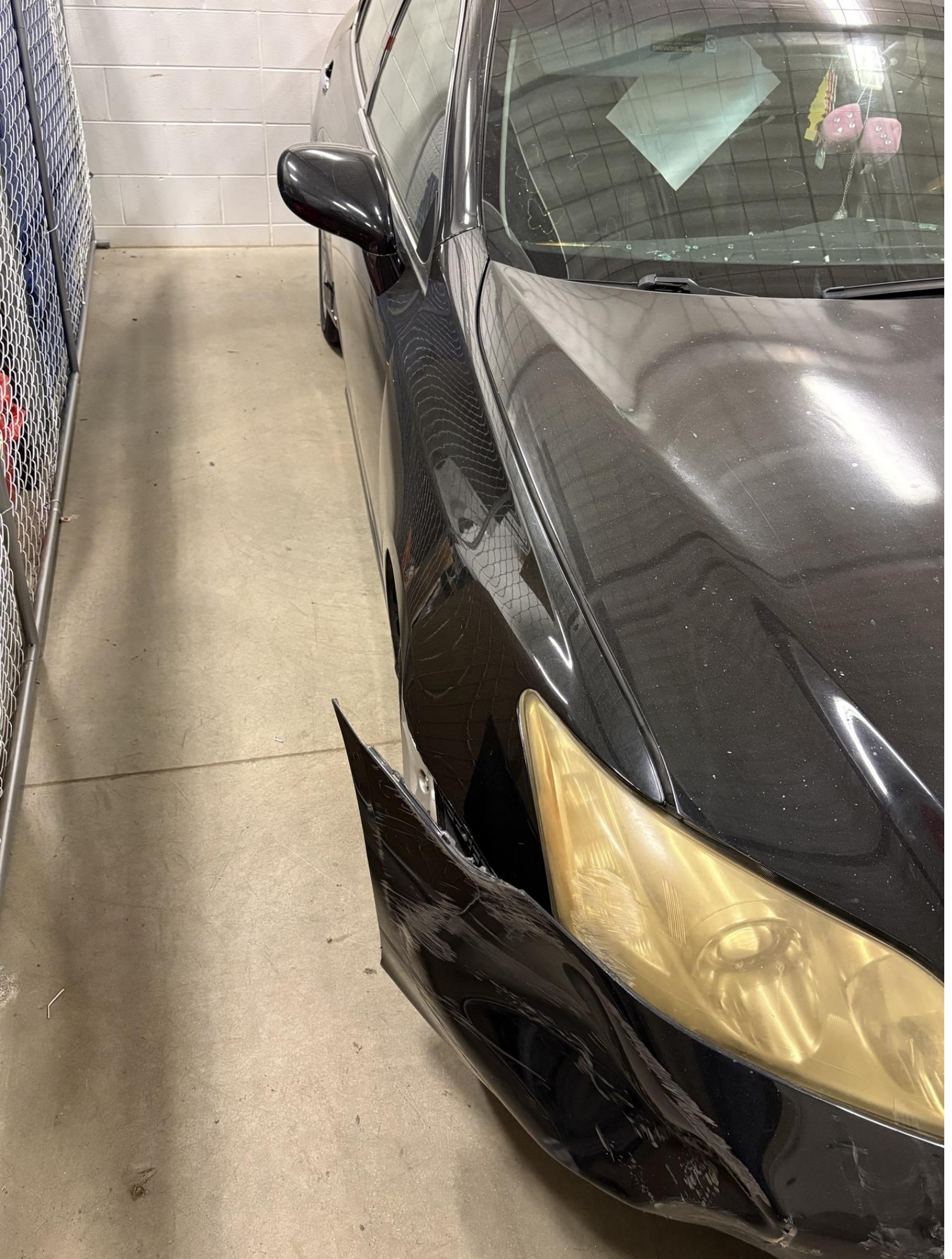
