#### **Investigative Request**

On Thursday, January 16, 2025, Captain Don Wensel of the Alliance Police Department requested assistance from the Ohio Bureau of Criminal Investigation's (BCI) Special Investigations Unit (SIU) and Crime Scene Unit (CSU) in conducting an independent investigation into the facts and circumstances surrounding an officer-involved critical incident. The incident occurred on January 16, 2025. The incident took place in the common hallway of the fifth floor of the Alliance Towers, U.S. Department of Housing and Urban Development Senior Housing, 350 South Arch Avenue, Alliance, Ohio. The incident resulted in the death of Mason French (French) and Stacy Pride (Pride).

#### Preface:

This report serves as a synopsis of the investigation into the January 16, 2025, shooting and subsequent officer-involved shooting in Stark County, Ohio. This report only summarizes the information that the investigative team determined to be the most useful in achieving an overall understanding of what occurred in this incident. Every fact and detail are not presented in this summary report. Therefore, it is recommended that each individual report from which this document is derived be read in order to obtain a complete understanding of this investigation. Further, audio and/or video recordings exist for the majority of the interviews conducted, revealing further details of statements given regarding the incident.

This investigation was conducted with the purpose of determining, to the extent possible, the facts and circumstances surrounding this incident. As unbiased collectors of fact, the investigative team has not and will not render any opinion of the

legality of officers' actions. Instead, it is anticipated that this investigation will provide the basis of information for decisions to be rendered by the appropriate authorities.

#### **Investigative Team**

BCI Special Agent Nicholas Valente (SA Valente) was assigned as the lead SIU case agent. SA Valente received assistance in the investigation from SA Jessie Bynum, SA Allison Fletcher, SA John Tingley, SA Andrew Harasimchuk, and SA Jack Shea. BCI Special Agents Larry Hootman and Chad Doran of the Crime Scene Unit processed the scene of the incident, documenting, preserving, and collecting possible evidence. The investigation was supervised by Special Agent Supervisor Charles Moran. Additionally, various personnel from the BCI crime laboratory performed scientific analyses on submitted items of potential physical evidence.

#### **Summary of Process**

The following is a partial list of investigative activities or methods which were employed during the course of this investigation, by the investigative team, in an effort to thoroughly and accurately locate and document all pertinent facts and circumstances regarding this incident:

- Recorded interview(s) of the two officers who discharged their weapons
- Recorded interviews of two officers who were involved in the incident, at the scene, or otherwise deemed to potentially have relevant information
- Neighborhood canvass of the area surrounding the scene
- Interviews of multiple civilian witnesses to the incident
- Interviews of family members or associates of French.
- Special agent attendance to post-mortem examination (autopsy) of both French and Pride
- Obtained and reviewed post-mortem examination (autopsy) and toxicology reports
- Obtained and reviewed police reports of prior law enforcement contacts with the subject
- Obtained and reviewed open and closed-source biographical information on the involved subject, including criminal history reports, OHLEG, driving records, etc.
- FBI National Crime Information Center (NCIC) checks on any non-law enforcement weapons involved in the incident (to determine if reported stolen)
- Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) trace on any non-law enforcement weapons involved in the incident (to determine ownership history)
- Review of all available body cameras involved in the incident

#### **Incident Summary/Overview**

On the morning of January 16, 2025, two 911 calls were placed to the Alliance Police Department (APD) requesting officers respond to the fifth-floor common hallway of the Alliance Towers, 350 South Arch Avenue. The first caller reported fighting and commotion in the hallway. The second caller reported hearing gunshots and a female voice stating that she had been shot.

Alliance Police Officers Kevin Brown (Ofc. Brown), Paul Vesco (Ofc. Vesco), and all responded to the scene. These four officers entered the building and rode up the elevator to the fifth floor together. As the officers exited the elevator, an uninvolved witness cautioned the officers, "He's got a gun on her. He shot her."

Ofc. Brown exited the elevator first and was followed by the other three officers. Almost immediately after exiting the elevator and entering the hallway, Ofc. Brown observed the subject and victim at the end of the hallway. Ofc. Brown raised his duty pistol and pointed it in the direction of the end of the hallway where the subject, (French), and the victim (Pride), were located. Ofc. Brown yelled, "He's got a gun. Put it down! On the ground now!" A voice could be heard in the distance and appeared to respond, "No."

Body-worn- camera (BWC) recordings of the incident appeared to show French pointing his arm and hand down towards Pride as Ofc. Brown approached him. French then momentarily backed out of the hallway and into Pride's apartment. Pride's apartment was the last door at the end of the hallway on the right. French briefly exited the view of Ofc. Brown's BWC before quickly reappearing. Upon reappearing in view of Ofc. Brown's BWC, French again leaned down and towards Pride with at least one arm extended out and towards her.

As Ofc. Brown finished yelling the order "Put it down! On the ground now!", a loud percussive sound consistent with a gunshot began. As the sound of this first gunshot began to fade away, a voice that appeared to come from the end of the hallway, presumed to be that of Pride, began yelling out "Ahhhhhhhhhhhhh." This first loud percussive sound is believed to be the sound of French's gun as he shot Pride while the officers began to approach him.

The group of four officers continued to walk down the hallway towards the subject and victim after French appeared to have just shot Pride in the officers' presence. A second loud percussive sound followed seconds later. This second loud percussive sound is also believed to have originated from French's pistol as he shot (or shot at) the victim a second time in the officer's presence.

Immediately after the gunfire stopped, Ofc. Brown and Ofc. Vesco walked to the end of the hallway where French and Pride were located. Both French and Pride were found lying face up. A small black pistol, with its slide locked back, was found on the ground between the two. Both Pride and French were pronounced dead in the hallway and were determined to have died as a result of the gunshot wounds they sustained.

#### **Decedents**

#### 1. Stacy Pride

Pride was a 57-year-old African American female at the time of her death. She was reported to be the on-again, off-again girlfriend of French. Pride lived in the last apartment on the fifth floor, directly in front of the common hallway where the shooting occurred.

#### 2. Mason French

French was a 63-year-old African American male at the time of his death. He did not live in the apartment building, and it could not be determined when he entered the building.

A relative of Pride told agents that French frequently abused Pride and had "pulled a gun on her" a couple of weeks prior to this incident. A relative of French told agents he believed the two began a relationship approximately two years ago, when French was released from prison and began selling crack cocaine to Pride. French's relative knew

the two had used drugs together. French was a daily drinker and the relative felt that the pair's relationship was toxic.

French had a lengthy criminal history, including an arrest for attempted murder and other charges in which French was ultimately sentenced to seven years in prison for felonious assault and burglary with weapons specifications.

French also had a history of crimes of violence against former romantic partners. The APD had 32 prior documented interactions with French including an incident where French reportedly pushed his then-girlfriend (not Pride) out of a moving car and attempted to strike her with the vehicle. In another unrelated event, French struck a different ex-girlfriend (also not Pride) to the point that the woman needed medical treatment from a hospital.

#### **Autopsy Reports**

The autopsy report for French was obtained from the Stark County Coroner's Office. A review of those documents revealed the following information:

Note that Pride did not appear to have her back visible to either officer who fired at any point while the officers fired their rifles. Pride, however, did clearly have her back visible to French during the time he is believed to have shot her in front of the officers.

#### **Physical Evidence**

The BCI Crime Scene Unit was requested to respond to the scene of the shooting to document and preserve any items of potential evidence. Multiple agents responded and processed the scene, to include photographing and mapping the area, as well as the search for, documentation, and collection of items of possible evidence. Detailed crime scene reports were completed with the below information only summarizing some of the more significant findings.

Fourteen rifle cartridge casings were photographed and individually collected from the apartment hallway.



A 9mm cartridge casing was found on the hallway floor near the door to Pride's apartment. A second 9mm cartridge casing was found near the door to the stairwell exit in the hallway. A 9mm cartridge casing was found inside the doorway of Pride's apartment, and a final 9mm cartridge casing was found on the kitchen floor of Pride's apartment. Two additional 9mm cartridge casings were found underneath the victim once her person was removed. In total, six 9mm cartridge casings were located near the entranceway to Pride's apartment.

A measurement was taken from French's center mass to the rifle cartridge casings. This measurement was recorded as approximately 49 feet.

Various items of potential evidence were submitted to the BCI Laboratory for analysis. The actual reports should be consulted as the following synopsis does not include many of the details from the full reports.

The BCI Firearms Section performed an analysis of the officers' firearms, as well as the firearm-related evidence collected from the scene, and autopsies (casings and bullets). By comparing evidentiary cartridge casings/projectiles to known standards from each weapon, identifications were able to be made in some instances as to which casings/projectiles were fired from each firearm. Of the casings/projectiles recovered, the following identifications were made:

The Beretta pistol used by French during the incident was linked to six 9mm luger cartridge cases and six fired bullets and bullet jacket fragments. Lab item #28 / Matrix item #30, a small bullet jacket fragment found in the scalp/head hair of the victim, Pride, was matched to French's pistol.

The Palmetto State Armory rifle used by was linked to seven fired cartridge cases, one fired bullet, and had similar class characteristics but was not conclusively linked to another bullet fragment. Note that the fired bullet linked to was the bullet removed from the right shoulder of Pride.

The Bravo Company Mfg. Rifle used by was linked to seven fired cartridge cases, one fired bullet and one bullet jacket. Note the bullet jacket linked to rifle was recovered from the right abdomen of French. The bullet linked to rifle was recovered from French's left abdomen wall.

Note the projectile recovered from French's peritoneal cavity was found to be unsuitable for comparison purposes due to a lack of sufficient reproducible individual detail or other identifying marks.

#### Witnesses

Multiple witnesses and neighbors were interviewed. Many reported they heard suspected gunfire. However, agents did not locate any non-law enforcement witnesses to the actual officer involved shooting.

Peggy Zeppernick (Zeppernick), who is deaf, shared with agents through her interpreter, Carolyn Dugan, that she was alerted to something happening outside of her apartment by her dog. When Zeppernick looked down the hallway, she saw a black man hitting what she then believed to be a second black male with some sort of cane or stick. Zeppernick observed the victim of the assault grab their head after being struck by the aggressor. Zeppernick believed she also saw a third party, a female, at the end of the hallway while the fight between the two men was taking place. Zeppernick then shut her door. When Zeppernick next opened her door, the fire alarm was going off, and she looked down the hallway again and noticed smoke in the hallway. Police were then in the hallway and told her to close her door. Zeppernick then shut her door.

Twila Wareham (Wareham) lives in the apartment directly across from Pride. The officer involved shooting occurred directly in front of Wareham's front door. Wareham heard yelling and screaming coming from the hallway in front of her apartment. Upon hearing the commotion, Wareham momentarily looked through the peephole but could not make out who was outside or what was happening. Wareham then backed away from her door and called 911 to report hearing the yelling coming from outside her door. Wareham next heard an unknown number of gunshots and took cover in her bathroom. Wareham did not exit her apartment, look through the peephole again, or otherwise see or hear anything relative to the incident after that point.

Scott Wilson (Wilson) lives in apartment 714 and stated that he woke up at approximately 0735 hours and began to watch the news, when he thought he heard a gunshot. Wilson stated that he then heard two more gunshots, causing him to walk down the stairs. When Wilson arrived on the fifth floor, he looked through the window in the door to the fifth-floor hallway and observed Pride on the opposite side of the door bleeding from her head. Wilson said French was trying to pull Pride inside the apartment by her arms. Wilson further explained that he heard Pride say something about being shot and French replied, "Yeah, I shot you twice". Wilson stated that he ran up the stairs and to an elevator where he told the police that French had a gun.

#### **Officer Interviews**

The following paragraphs are abbreviated versions of each officer's account of his or her actions pertaining to this incident and/or discharging their weapon. More detailed accounts can be found by reading the separate reports written by the interviewers and by reviewing the recordings of each interview.

#### Officer Vesco:

Ofc. Vesco was identified as being a police officer who witnessed and/or had some level of involvement in the January 16, 2025, officer involved shooting.

Ofc. Vesco arrived at the apartment building around the same time as Ofc. Brown,

The four officers rode in the apartment elevator together to the fifth floor. As the other officers exited the elevator. Ofc. Vesco's attention was focused on an elderly

The four officers rode in the apartment elevator together to the fifth floor. As the other officers exited the elevator, Ofc. Vesco's attention was focused on an elderly gentleman who was standing at the elevator doors. This elderly man told the officers that the subject was at the end of the hallway and had just shot the victim.

Ofc. Vesco told agents, "And as I'm getting, the last one off the elevator, I hear Brown say, 'Oh shit, he's got a gun.' And then Brown's giving orders to drop it, get on the ground. So, as I'm coming up online, um, Brown's to my left, um, and and And then I'm kind of like, it's not long enough, the hallway, to get all four of us across. So, I'm kind of like in the, in the back of it. And that's when, um, yelling commands for him to get down, drop it. Um, I could see like the, like a football field was the way I looked at it. I could see like a quarterback. I could see everything that was going on. Um, as I'm getting off the elevator, I could, as we're yelling this, you know, drop the gun, get off, he shoots the victim, the suspect shoots the victim at point blank. Um, and then that's when we're like, tell him to get down, drop it. Um, and that's when he failed to comply. And the, um, and then, um, took shots at the suspect."

When asked, Ofc. Brown stated that he was confident he observed the subject shoot the victim and recalled seeing the muzzle flash of the subject's gun after the subject shot the victim.

When asked if he observed the subject point the gun or fire at anyone else beside the victim, Ofc. Brown stated (11:55 mark of recording) "No, he still had it in his hand pointing at the victim." Ofc. Brown added that he believed the subject was still pointing his pistol at the victim lying on the hallway floor when the officers began to shoot at the subject.

Ofc. Vesco stated the officer's gunfire towards the subject was very quick and lasted "less than a few seconds." Once the officers stopped firing, Ofc. Vesco's view down the hallway was obstructed by the smoke created from the gunfire. Once the shooting stopped, Ofc. Brown began to walk down the hallway towards the subject and victim. Ofc. Vesco followed behind Ofc. Brown as he approached the subject and victim.

Ofc. Vesco reported upon reaching the end of the hallway, "I see the, um, female victim. Now I can tell she's on her back. Um, the, the male suspect was now on his back and now he had pretty much fallen over top of her. He was just in front of her now she was kind of behind him. Now he was in front of her, um, at which time I could see the pistol with the, the slide open laying on the ground. So, I wanted to make sure that the pistol was somewhat secure, that now we know the slide locked back. It's not, you know. Um, so I reached in my, um, cargo pockets, pulled out rubber gloves, checked for a pulse on the suspect, um, at which time Brown, uh, was trying to see if there was a pulse on the female victim. I immediately got on the radio and called for an ambulance, I believe once or twice. Um, I said, uh, we need a 46, or I might have even said ambulance. We said we need a 46 or an ambulance here asap. And I know I said it more than once, um, to get him there. Um, so then we just kind of locked down this crime scene to see. I could see that the male suspect was, um, deceased at that time."

When asked why he did not fire his weapon, Ofc. Vesco said, "Uh, due to my, uh, the hallway, like I said, we couldn't get everybody online and through my training and experience, number one, I'm not gonna shoot behind an officer just for the safety reasons, you know? We've all been through my training. I was on SRT and all this stuff. You just drilled in your head, you gotta get online to fire. I mean, and I would never shoot behind an officer's head or something like that, taking the chance of shooting them in the back of the head. And at the same time when the smoke was going off from the powder from the, uh, cartridges, I'm not gonna shoot blindly into a cloud of, that's the way I felt. It was more of a safety issue. And there was nowhere for me to get up online with those guys."

When asked what he thought was going to happen after the subject shot the victim, Ofc. Vesco said, "I can tell you what I thought. What could happen next? Um, A, we have to protect her from getting shot again. B, he's gonna turn around and shoot us, at us, or C, an innocent person comes out of the apartments that has no idea what's going on and now he's in this whatever state of mind he's in and he decides to shoot a, um, an innocent civilian. So those were the three things that kind of played out in my mind very quickly."

When asked if he feared for his safety, the safety of the other officers, or the victim during the incident, Ofc. Vesco stated, "Well, for the woman's safety, um, we don't

know what condition she was in. I don't know if she was alive. I had to treat her like she's alive. I would never, you know, not protect somebody that's being a victim of, of being shot and basically executed in front of us. I mean, we're going to protect her first. Um, and I don't know what, like I stated, I don't know what his intentions were or is he gonna turn the gun on us next? Desperate people do desperate things. So, I don't, you know, we have to treat everything as the situation until we can make sure that the threat is no longer."

When asked if he observed any actions of the other involved officers he felt was inappropriate or potentially criminal in nature, Ofc. Vesco said "No, sir."

#### Officer Brown:

Ofc. Brown was identified as a police officer who witnessed and/or had some level of involvement in the officer-involved shooting.

Ofc. Brown continued, "I'm not 100 percent sure. I don't know if he, what apartment they were in at that time or nothing like that. Uh, he kind of stepped to the right, disappeared. Um, I don't know if he walked into the apartment, but there's a little, I guess he could kind of step back with the walls, have the doors reset a little bit, and he kind of disappeared from my view. Uh, I told the rifles to get up front. We started going down the hallway. Uh, once we started moving down the hallway, we didn't get very far. He reappeared again and the guys engaged him."

When asked, Ofc. Brown clarified that when he stated, "the guys engaged him", he was referring to and and firing their rifles at the subject.

Ofc. Brown believed at the moment and and and fired their rifles he was standing behind these officers and had a hand on each of their shoulders.

When asked to describe moving or assisting the two officers who fired into position in front of him, Ofc. Brown stated, "Uh, it seemed like a long shot to me if I had to take it with a handgun. Uh, not to mention he kind of ducked outta my view for a second. Um, I did not feel comfortable with a handgun to do that. So, I said rifles up front. Uh, the way we're taught is you have to be online or lateral distance to engage somebody. And I knew behind me, I did not want them shooting with me in front of them. And I, so I shoved the one guy I don't even know which one I grabbed. I didn't get to look, I pushed him in front of me and then I, whoever was next to him, I pushed him online together. So, they would be about shoulder to shoulder together. So, they would be online."

When asked if he believed the two officers began to fire before he reached back to help move them or after that, Ofc. Brown stated he believed the two officers did not begin to fire until they were in front of him.

When asked, Ofc. Brown stated he had "no idea" how many times the two officers fired. Ofc. Brown described the officer's gunfire as a quick volley rather than a long or sustained exchange or one having any pauses or breaks in shooting.

Ofc. Brown stated that he did not get a good look at the subject at the moment the two officers began to fire at the subject. At that time, Ofc. Brown's focus of attention was the two officers themselves. Once the two officers stopped firing there was a large cloud of smoke in the air. Ofc. Brown's view down the hallway became obstructed due to the smoke.

When Ofc. Brown looked down the hallway he observed the subject and the victim lying on the hallway floor. Ofc. Brown told the officers to stop firing and lower their weapons. Ofc. Brown then began to walk in front of the two officers who fired and towards the subject and victim.

Ofc. Brown could not recall what he did first when he reached the end of the hallway. However, Ofc. Bown did recall he and the other officers checked the subject and victim for a pulse and cleared the open apartment at the end of the hallway when they reached that point. Ofc. Brown stated he personally checked the female victim at the end of the hallway. When asked what specifically he did to check her, Ofc. Brown stated, "Uh, when I first got there, it looked like she was still alive, so I yelled, uh, to whoever was behind me as I was getting my gloves out before I touched her, to uh, gimme an ambulance. Uh, just as I got I think one or both of my gloves on. I looked at her, and it appeared that she, she, she was looking at me, and it appeared, uh, her

breath left, and her head turned to the left, and that was the end of it for her." Ofc. Brown believed Ofc. Vesco called for EMS. The fire department responded, put monitors on the subject and victim, and found no signs of life for either party.

When asked what he thought was going to happen after he observed the subject shoot the victim, Ofc. Brown stated "Uh, wasn't a hundred percent sure. I thought maybe, uh, he would fight us, but at that point I didn't care. It was a rescue mission. We were there to make sure she was okay or, or, do our best to save her at that point in time. So, I considered her basically to be a rescue."

Ofc. Brown stated he did not fear for his own safety, citing he did not even have time to think about that. Ofc. Brown stated he feared for the safety of the other officers and victim. Those fears were based on, "Uh, didn't know (if) he was gonna start shooting at us, obviously. Uh, I did push the two guys in front of me. Um, 'cause they had long guns. Uh, but way I look at it is we're here to save the public, not, so join, the time to giddy up. And, uh, I was concerned for her. I just wishing, her, get shot. I don't know if she'd been shot previously or if any other injuries had occurred to her physically or anything like that. So, once I saw him raise a gun and shoot her, we were, it was a rescue operation to, to save her if it was possible."

When asked what led to his decision to exit the elevator first, Ofc. Brown stated that the choice was probably made because he had the most experience of the group of officers.

When asked, Ofc. Brown clarified that at the moment he had his hands on the shoulders of the two officers who fired he was not actively pushing them. Rather he was holding them in position and felt they started to lean back against him. Ofc. Brown described when the two officers who fired began to lean or push back against him, "I looked at 'em and I said, guys, we're in the middle of a fucking hallway, we got nowhere to go."

Ofc. Brown did not believe any of the actions of the involved officers were inappropriate or potentially criminal in nature.



Two 911 calls were placed regarding this incident.

The first call received and saved as "Section 911 Call Neighbor" included a person reporting they lived in unit 516 and "There's a big commotion out in the hallway. A guy and a girl out there fighting. I don't know what's going on." The dispatcher advised the caller that she would send police and the call ended.

The second call received and saved as "Second 2nd Caller" included a caller reporting that they lived on the fifth floor, heard fighting, then gunshots followed by a woman yelling that she had been shot. The caller refused to identify themselves and stated they did not open their door or look outside/down the hallway. After hearing the gunshots, the caller reported that she called 911 and hid in her bathroom. The caller told the dispatcher, "I heard the shots fired and I heard her say 'He shot me, he shot me!' Okay, that's all I heard. I am hiding in my apartment, and I am not moving, so get up here to the fifth floor."

#### **Video Recordings**















Ofc. Brown then appeared to check Pride's carotid artery for a pulse.





Ofc. Brown and another officer who had just arrived on scene then checked Pride's open apartment for signs of anyone else inside. The officers did not locate anyone inside Pride's apartment. While checking the apartment, Ofc. Brown's BWC captured a defect in the paneling on Pride's closet door, just inside the main entranceway of the apartment.

While Ofc. Brown checked Pride's apartment Ofc. Vesco cleared the stairwell at the end of the hallway.

#### Conclusion

On the morning of January 16, 2025, two 911 calls were placed to APD requesting officers respond to the fifth-floor common hallway of the Alliance Towers, 350 South Arch Avenue. The first caller reported fighting and commotion in the hallway. The second caller reported hearing gunshots and a female voice stating she had been shot. Multiple tenants of the building also reported hearing commotion and gunshots coming from the general area of the end of the fifth-floor hallway just outside Pride's apartment. Based on a review of BWC video, interviews conducted with witnesses and involved officers, evidence collected from the scene itself, laboratory testing and the review of autopsies it is believed French shot Pride at least once prior to the arrival of police.

Body-worn camera (BWC) videos showed that Ofc. Brown exited the elevator first and was followed by the other three officers. Almost immediately after exiting the elevator and entering the hallway, Ofc. Brown observed the subject and victim at the end of the hallway. Ofc. Brown raised his duty pistol and pointed it in the direction of the end of the hallway where the subject, (French), and the victim (Pride), were located. Ofc. Brown yelled, "He's got a gun. Put it down! On the ground now!" A voice could be heard in the distance and appeared to respond, "No."

BWC videos of the incident appeared to show French point his arm and hand down towards Pride as Ofc. Brown approached him. French then momentarily backed out of the hallway and into Pride's apartment. Pride's apartment was the last door at the end of the hallway on the right. French briefly exited the view of Ofc. Brown's BWC before quickly reappearing. Upon reappearing in view of Ofc. Brown's BWC, French again leaned down and towards Pride with at least one arm extended out and towards her.

BWC videos showed Ofc. Brown finished yelling the order "Put it down! On the ground now!", a loud percussive sound consistent with a gunshot began. As the sound of this first gunshot began to fade away, a voice that appeared to come from the end of the hallway, presumed to be that of Pride, began yelling out "Ahhhhhhhhhhhhh." This first loud percussive sound is believed to be the sound of French's gun as he shot Pride while the officers began to approach him.

BWC videos showed the group of four officers continuing to walk down the hallway

towards the subject and victim after French appeared to have just shot Pride in the officers' presence. A second loud percussive sound followed seconds later. This second loud percussive sound is also believed to have originated from French's pistol as he shot (or shot at) the victim a second time in officer's presence. BWC videos showed Ofc. Brown, who was in the lead position of the approaching officers, momentarily stopped, allowing and and to take the lead positions. While doing so, Ofc. Brown yelled, "Go, go, go. Get up here. Get up here motherfuckers, go." Ofc. Brown reached out and grabbed the left arm of an apparent attempt to expedite into a lead position. Ofc. Brown then grabbed the left arm of to pull him forward more quickly as well. BWC videos showed Ofc. Brown placed his hand on the back shoulder of At this same time, French partially reappeared from Pride's apartment into the common hallway. French faced the group of officers and appeared to raise his right arm and hand upward. then yelled to French, "Drop the weapon." Based upon the available evidence. French is believed to have then shot himself in the head with his own pistol. French then fell onto the hallway floor as began to fire their rifles in his direction. began to fire almost simultaneously. Based upon the available evidence, it could not be determined which officer fired first or last. It is, however, clear that both officers began to fire and stopped firing within a fraction of a second of each other. Both officers began to fire approximately 8 seconds after crossing the threshold of the elevator doors after witnessing Pride having just shot French, who lay helpless on the hallway floor. and BWC videos showed stopped firing approximately 1.87 seconds after they began to fire. All available evidence showed that fired seven times. One bullet fired by was recovered from the right shoulder of Pride. seven times. Two bullets recovered from French's abdomen were matched to riffle. French is believed to have shot at Pride or inside her apartment four times prior to police arrival. French is believed to have then shot or shot at Pride twice in the officer's presence. The available evidence showed one of the bullets French is believed to have fired into

BWC videos showed that immediately after the gunfire stopped, Ofc. Brown and Ofc. Vesco walked to the end of the hallway and checked Pride and French for signs of life and requested EMS respond. Both French and Pride were pronounced deceased at the scene.
