Narrative:

On Friday, July 05, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) compiled background information on Mathue O'Malley (O'Malley), a subject involved in the incident on June 13, 2024. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit and the Youngstown Police Department (YPD).

SA Lieber reviewed the information and noted the following:

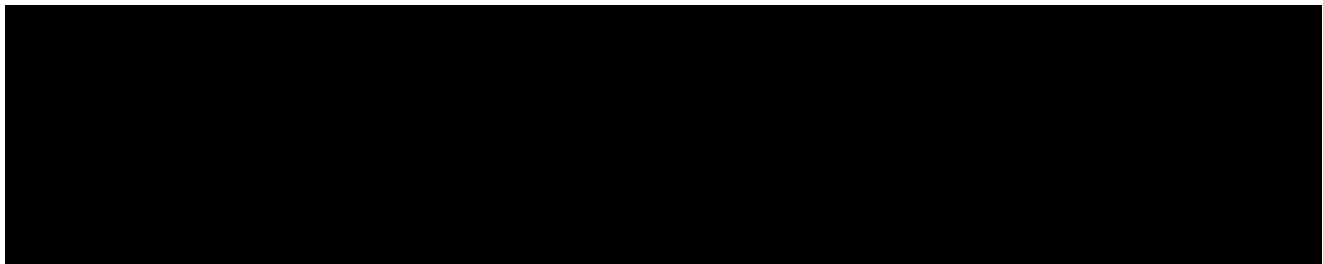

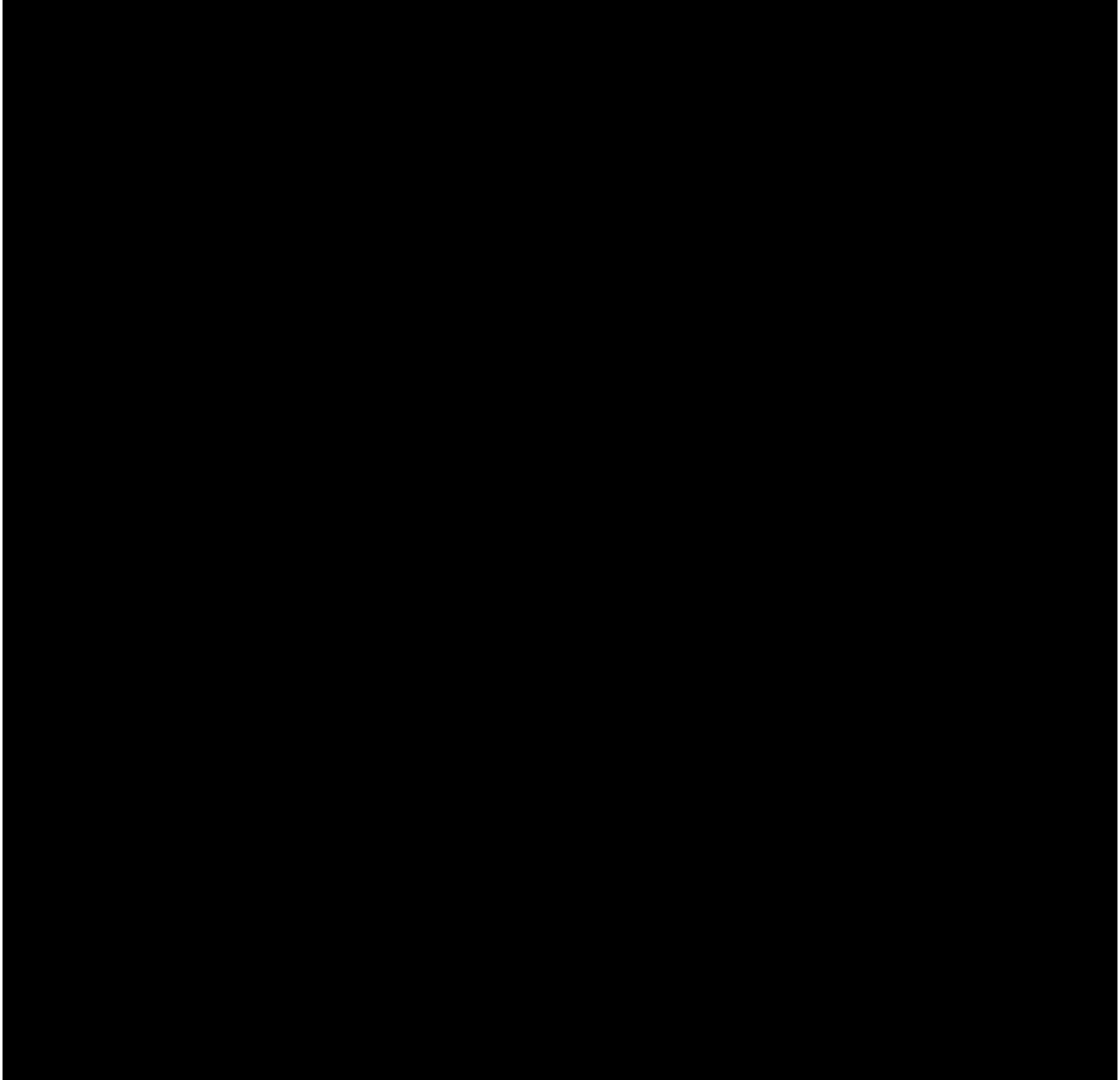

Narrative

On 09/02/2023 at approximately 2012 hours, I, Sergeant K. Young, was working patrol in cruiser K9-136. At this time, I observed a white Chevrolet Impala traveling westbound on East Main near Manor Hill to have dark window tint. I initiated a traffic stop with the Chevrolet bearing Ohio registration, Q964763, On East Main near hood. I approached the vehicle, identified myself and explained the reason for the traffic stop. The driver, Mathue Allyn O' Malley advised that he recently purchased the vehicle and put the window tint on it. It should be noted that the driver was smoking a Black and Mild, had multiple air fresheners in the vehicle and appeared to have recently sprayed cologne. I requested K9 Officer A. Young to the scene.

Soon after, K9 Officer A. Young arrived on scene in cruiser K9-126 and O' Malley was requested out of the vehicle. I explained that K9 Officer A. Young was going to deploy his partner Nix around the vehicle for a free air sniff and O' Malley advised that there may be a small amount of marijuana in the vehicle. K9 Officer A. Young then had the two passengers exit the vehicle they were seated as follows: front seat passenger [REDACTED] and rear passenger seat [REDACTED]. K9 Officer then deployed his partner Nix around the vehicle for a free air sniff. K9 Officer A. Young advised that Nix indicated on the driver side of the vehicle and the trunk.

I performed a probable cause search of the vehicle and K9 Officer A. Young cleared while K9 Officer DeBarr arrived on scene. During the probable cause search of the vehicle I located a marijuana blunt in the cup holder ash tray and I located one pack of Eden's Trees Premium marijuana floor in the rear seat pocket on the passenger seat. The total weight was approximately 15.25 grams of marijuana.

O' Malley took ownership of all marijuana located in the vehicle. O' Malley was cited into Mahoning County Court #5 on 09/08/2023 at 0900 hours and charged with the following:

1. Window Tint- 4513.241C
2. Drug Abuse- 2925.11A

O' Malley was provided with his paperwork and released. All evidence was secured into locker A5.

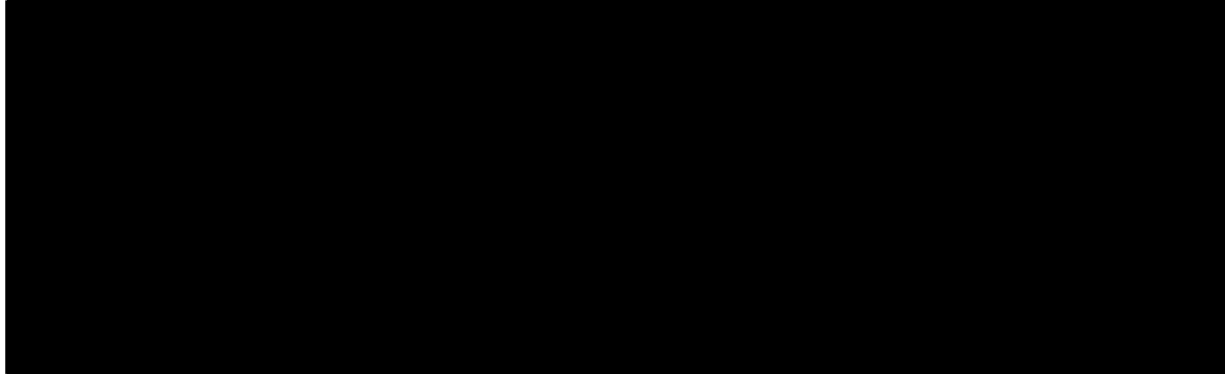

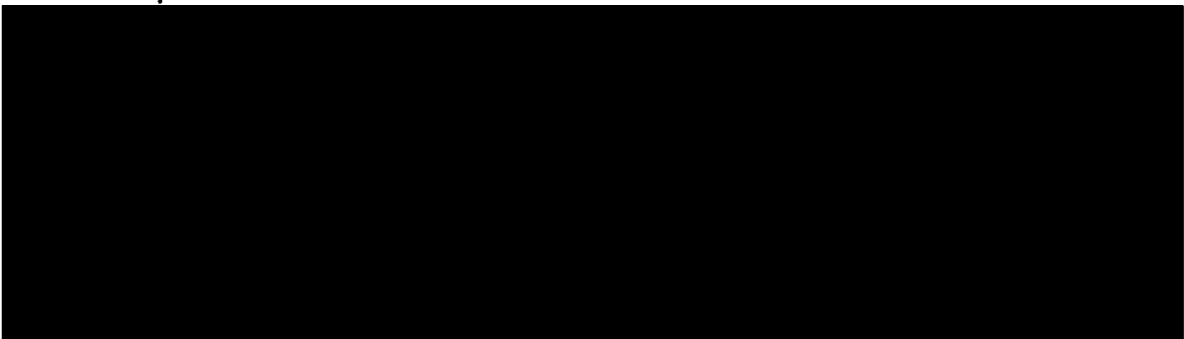

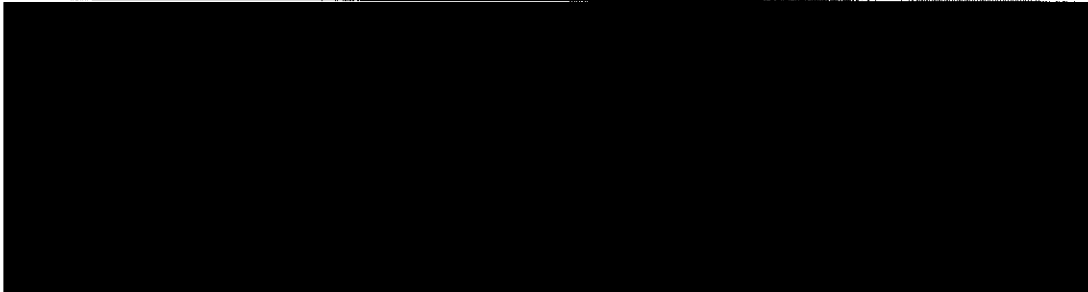
On 03/22/2024 at 3:11 PM, Officer Evans was dispatched to 81 Tremble Avenue for a follow up regarding an incident that occurred on 03/21/2024.

Upon arrival Officer Evans spoke to Mathue Omalley regarding the matter. Omalley stated that on 03/21/2024 at 3:57 PM, he was working on the layout of how he is going to build a fence at 89 Tremble Avenue. While Omalley was doing such, [REDACTED] who [REDACTED] came outside holding a firearm to what Omalley stated looked like a black and gray "Mac-10 possibly with a Suppressor". While [REDACTED] was holding the firearm she stated to Omalley "there is gonna be a problem". Following the altercation Omalley walked away to clear his head and avoid conflict. Due to the severity of the crime a criminal history check was conducted on [REDACTED]

[REDACTED] Omalley also stated that following a prior incident on 03/16/2024, [REDACTED] was sitting on her front porch with the same firearm stated above, tapping it on the floor.

Omalley was advised that a report will be on file and forward to The Detectives Division for an investigation.

On the above listed date and time, Officers Vukovich and Baker were dispatched to 296 Reed Ave in reference to a 911 call/report from Ed Newsome (291 Reed) of a burglary in progress at that location. Newsome stated that he was checking his neighbor's house at 296 Reed to which he has a key and when he entered he heard people upstairs. Newsome knew no one was supposed to be there due to the fact that the residents were gone and asked him to check on the house. Newsome announced himself, no one answered so he walked back out the front door where he had entered and dialed 911.

Vukovich arrived on scene first and witnessed Newsome running north on 15th St. toward Gordon Ave. Vukovich stopped and Newsome turned around and told Vukovich that the two suspects had left out the back of the house prior to his arrival and were running through the backyards from 296 Reed toward 15th St., and he was chasing one of them who was wearing a black hoodie with white lettering on the front of it. All of a sudden, while Newsome was pursuing the first suspect north on 15th toward Gordon, he stated that Mathue O'Malley ran out in front of him through some bushes coming from exactly the same location as the first suspect had ran from. O'Malley was out of breath and Newsome, but said he was chasing after people who broke into 296 Reed Ave saying something like, (paraphrase), "did you catch him?". Newsome stated O'Malley then tried to act like he was not running from his appearance was disheveled and was startled by Newsome. Newsome stated O'Malley then tried to act like he was not running from eluding to the fact that he knew someone broke into 296 Reed and putting himself at the scene. Vukovich advised the description of the suspects over the radio, the direction of travel (north on 15th toward Gordon) and asked Newsome where O'Malley was now. Newsome said he ran up 15th St. and the other suspect ran west on Gordon and was heading through backyards.

At this time, Officers Baker, Gulu, and Paviansky arrived on scene to assist and set up a mobile and foot perimeter. Vukovich advised Baker that O'Malley was identified at the scene and was departing from the area and was now a suspect associated with a felony. Vukovich spoke with two other neighbors, Janet Kane and Nicholas Pondillo, who also identified O'Malley moving through the backyards and described him as whistling in code as to call someone. They were both familiar with O'Malley by face and by name and knew him personally and advised Vukovich they were sure it was him. Officers Gulu and Paviansky were on foot patrol of the area while Vukovich investigated the residence of 296 Reed Ave. Vukovich observed a rear window of the house partially open and items knocked over as if someone had crawled through that area. Vukovich also observed the rear door nailed shut and secure and no other means of exit other than the window. (Photos Taken)

(Narrated by Baker) Baker saw a person who he believed to be O'Malley from previous dealings, on 15th St. near Gordon Ave. At this time, Baker approached the male and asked for his identification. The male refused to answer Baker, and proceeded to ask Baker for his badge number. The male continued to elude Baker's request for identification, at which time Baker asked if he was Mathue O'Malley, to which he advised no, that's my cousin's name. Baker shined his flashlight on the male, finally identifying him as Mathue O'Malley, again due to previous dealings. At this time O'Malley was advised he was being placed under arrest for falsification and obstructing official business. While attempting to handcuff O'Malley (due to the above listed charges, as well as being a suspect in a burglary), O'Malley turned away from Baker and would not place his hands behind his back. Baker again attempted to handcuff O'Malley, who yelled "fuck you" multiple times, still refusing to allow Baker to handcuff him. After several orders to comply, Baker had to grab O'Malley's arms, who continued to struggle away until Baker was able to secure his arms and O'Malley was finally placed into handcuffs (gapped and double locked), and secured into the rear of marked unit #106. O'Malley was then transported to the scene for identification purposes where Newsome, Kane and Pondillo positively identified him as O'Malley and who was the one running through backyards a short time before.

(Narrated by Gulu) Meanwhile, Officer Gulu observed a male then coming from the rear yards of 140 Bright Avenue and sit down on the rear porch. Gulu approached the male who was sweating and out of breath. Gulu identified the male as Jerome Williams, O'Malley's cousin. Jerome fit the description of the male wearing a black hoodie with white lettering. Gulu observed Jerome taking something out of his pocket and sitting on it. Gulu asked what it was and Jerome denied that he had not set on anything. Gulu then had Jerome stand and observed 2 gold watches and a piece of gold band necklace. Gulu then detained Williams and proceeded to walk him back to Paviansky. Paviansky patted down Jerome Williams for weapons and discovered the other half of the gold necklace from Jerome's pocket.

(Narrated by Vukovich) Paviansky brought Jerome Williams back to the scene for identification. Newsome positively identified him as the male he saw running from the rear of the residence in the same black hoodie with white lettering as previously described to Vukovich. Newsome, Kane and Pondillo all provided voluntary, written witness statements to the incident (see attached documents) Paviansky started to trace the path that the witnesses said the suspects traveled upon fleeing the residence and heading to 15th St. and Gordon near where Newsome said he saw the first suspect flee (Williams) looking for more stolen items along those locations. A Playstation 3 gaming console was found along side of the residence on the corner of 15th and Gordon (239 Gordon Ave) (Photos taken and console seized as evidence.)

Officer Vukovich spoke with the homeowner/victim, Daniel M. Hagens and his family, and other resident victims including Brett Weidner and Clara Weidner who began a preliminary inventory of the stolen items from the house which did include a Playstation 3 gaming console, and misc jewelry. All items recovered by Gulu and Paviansky were positively identified by Brett and Clara Weidner as their stolen property from the residence. All items were later logged as evidence and secured in the evidence locker for the detective. Due to the above listed circumstances including eyewitness accounts and statements, positive identification of both male suspects, the recovery of stolen property on or near the suspects, both O'Malley and Williams were now charged with burglary.

Both suspects were transported to Campbell City Jail and secured in holding for processing. Esther O'Malley and Jo Ann Bussey (parents of the suspects) were notified of the incident and that both suspects were going to be transported to JJC for incarceration on the above listed charges. Bussey declined coming to see or speak Williams at CPD prior to his departure. Esther O'Malley did come and speak with her son Mathus prior to his departure to JJC.

***UPDATE, on 10/31/14 Officer Vukovich updated the address of the incident, victim and the witnesses. Initially the incident was recorded as 291 Reed, that was an error and the incident occurred at 296 Reed Ave. The report was corrected and updated as soon as the error was discovered.

ON 11/09/2015 AT 8:34 PM JOANN BUSSEY, MOTHER OF DREAMA WILLIAMS, CAME INTO THE CAMPBELL POLICE STATION WITH WILLIAMS TO REPORT MATHEU OMalley ASSAULTED HER DAUGHTER 20 MINUTES PRIOR AT A RESIDENCE ON TREMBLE AVE. BUSSEY BEGAN TO TELL OFFICER MANNING WHAT HAPPENED AND THEN TURNED TO WILLIAMS AND ADVISED HER TO CONTINUE WITH TELLING OFFICER MANNING WHAT HAPPENED. WILLIAMS ADVISED "I DON'T KNOW" AND "STUFF". BUSSEY ORDERED HER DAUGHTER TO BE SPECIFIC AND WILLIAMS TOLD OFFICER MANNING OMalley PICKED HER UP SEVERAL TIMES THROWING HER ONTO A BED AND CHOKED HER. OFFICER MANNING ASKED WILLIAMS TO BE SPECIFIC ON WHAT HAD OCCURRED AND WILLIAMS WAS VERY HESITANT TO COOPERATE. OFFICER MANNING ASKED WILLIAMS IF SHE WANTED OMalley PLACED UNDER ARREST AND SHE ADVISED "YES". OFFICER MANNING ADVISED WILLIAMS THAT IN ORDER FOR OFFICERS TO TAKE THAT COURSE OF ACTION SHE WOULD BE REQUIRED TO COOPERATE BY TELLING SPECIFIC DETAILS, AND IF IT WENT AS FAR AS OMalley BEING CHARGED SHE WOULD BE REQUIRED TO TESTIFY TO THE SAME FACTS THAT SHE WAS PROVIDING TO POLICE AT THIS TIME.

IT APPEARED TO OFFICER MANNING THAT WILLIAMS WAS NOT BEING COOPERATIVE AND HOLDING SOME INFORMATION BACK. THROUGH FURTHER QUESTIONING WILLIAMS STATED SHE SMACKED OMalley IN THE FACE AFTER BEING THROWN ONTO THE BED THE FIRST TIME. OFFICER MANNING ADVISED WILLIAMS THAT IT WAS ALRIGHT TO TELL POLICE AND THAT SHE JUST HAD TO BE COMPLETELY HONEST. WILLIAMS STATED SHE WAS AT THE RESIDENCE ON TREMBLE AVE WHERE OMalley TOOK HER PHONE. WILLIAMS STATED SHE BEGAN ARGUING WITH OMalley TO GIVE BACK HER PHONE. OMalley THEN THREW HER PHONE BREAKING IT AND PICKED HER UP THROWING HER ONTO A BED. WILLIAMS STATED SHE THEN SMACKED OMalley IN THE FACE AND OMalley CONTINUED PICKING HER UP THROWING HER ONTO THE BED. WILLIAMS THEN STATED SHE KICKED OMalley AND OMalley KICKED HER IN RETURN EACH TIME. WILLIAMS STATED THAT OMalley THEN GRABBED HER BY THE NECK CHOKING HER AND STATED "I'M NOT WORRIED ABOUT YOUR FAMILY CAUSE I'LL JUST GO UP THERE WITH MY GUN". THEN WILLIAMS AND BUSSEY ADVISED IT HAD OCCURRED BEFORE RECENTLY BUT WILLIAMS JUST ADVISED HER MOTHER TODAY.

OFFICER MANNING, SEEING SLIGHT GAPS IN THE STATEMENT OF WILLIAMS ASKED BUSSEY TO COME INTO THE REPORT WRITING ROOM IN FRONT OF DISPATCHER VARGAS. OFFICER MANNING ADVISED BUSSEY THAT HE HAS OBTAINED MANY STATEMENTS OF VICTIMS OVER THE YEARS AND THAT HE BELIEVED WILLIAMS IS STILL HOLDING BACK SOME INFORMATION. THIS WAS DONE TO TRY AND HAVE BUSSEY CONVINCED HER DAUGHTER TO FILL IN GAPS. BUSSEY REPLIED "I DON'T CARE, I STILL WANT TO PRESS CHARGES". OFFICER MANNING ADVISED BUSSEY THAT A REPORT WOULD STILL BE COMPLETED REGARDLESS AND THE DETECTIVE AND LAW DIRECTOR WOULD DO ALL THE FOLLOW UP REGARDING THIS INCIDENT. OFFICER MANNING DID ADVISE BUSSEY THAT OMalley WOULD MOST LIKELY BE QUESTIONED REGARDING THESE EVENTS AND BUSSEY STATED "WHAT'S THE POINT IN DOING THIS THEN" AND WALKED BACK INTO THE LOBBY. BUSSEY BEGAN TO LEAVE AS SHE STATED "HE SAID NOTHING IS GONNA HAPPEN".

OFFICER MANNING STOPPED BUSSEY AND ADVISED HER IN FRONT OF HER DAUGHTER THAT SHE MISUNDERSTOOD WHAT WAS SAID TO HER AND THAT OFFICER MANNING DID NOT SAY ANYTHING TO THAT EFFECT. OFFICER MANNING CLARIFIED THE CRIMINAL JUSTICE PROCESS FOR THIS TYPE OF COMPLAINT AND ADVISED HER THE DETECTIVE WOULD BE IN CONTACT WITH HER. OFFICER MANNING OBSERVED A SLIGHT RED MARK ON THE LEFT SIDE OF WILLIAMS NECK WHICH APPEARED FRESH AND SMALL MARKS ON WILLIAMS RIGHT ARM WHICH APPEARED TO BE OLDER THAN THE MARK ON HER NECK. BUSSEY LEFT THE STATION AND THIS REPORT WAS FORWARDED TO THE DETECTIVE.

AUSTINTOWN POLICE CALLED THE STATION REQUESTING CAMPBELL POLICE TO MAKE CONTACT FOR THEM AS THEY WERE ENTERING THE FEMALE INTO LEADS AS A RUNAWAY. OFFICERS ARRIVED AT THE RESIDENCE AND SPOKE TO THE DAUGHTER OF ESTER O'MALLEY WHO WAS ASKED WHO'S HOUSE IT WAS SINCE OFFICERS BELIEVED ESTER LIVED AT 213 TREMBLE AVE. THE DAUGHTER ADVISED THE RESIDENCE WAS HER MOM'S HOUSE AND SHE WAS IN FACT HOME. OFFICER MANNING REQUESTED TO SPEAK WITH HER AND ESTER O'MALLEY CAME TO THE DOOR. OFFICERS EXPLAINED WHY THEY WERE THERE AND ASKED ESTER FOR PERMISSION TO SEARCH THE INSIDE OF HER HOME FOR THE JUVENILE. ESTER GAVE FREE AND VOLUNTARY CONSENT.

OFFICERS ENTERED THE RESIDENCE AND BEGAN CHECKING THE FIRST AND SECOND FLOOR. OFFICER MANNING WENT TO THE SECOND FLOOR AND WHILE CONDUCTING THE INVESTIGATION HEARD MATHUE O'MALLEY YELL "MANNING YOU HAVE TO GET THE FUCK OUT OF MY HOUSE". SGT BUTCH ATTEMPTED TO EXPLAIN WHY THEY WERE THERE BUT O'MALLY CUT HIM OFF AGAIN SAYING "MANNING FOR REAL GET THE FUCK OUT OF MY HOUSE". MATHUE BEGAN WALKING UP THE STAIRS SAYING "VUKOVICH AND THE OTHER GUY ARE COOL BUT MANNING YOU ARE GOING TO GET HE FUCK OUT OF MY HOUSE". OFFICER MANNING ADVISED O'MALLEY THAT HE IS NOT TO INTERFERE WITH OFFICERS CONDUCTING THE INVESTIGATION AND IF HE DID HE WOULD BE PLACED UNDER ARREST. O'MALLEY ONCE AT THE TOP OF THE STAIRS REPLIED "ARRESTED FOR WHAT? GET THE FUCK OUT OF MY HOUSE" AS HE RAISED HIS HANDS FROM HIS SIDES. OFFICER MANNING BELIEVING O'MALLEY MAY BE ATTEMPTING TO PHYSICALLY REMOVE HIM, TURNED AND TACKLED/PINNED O'MALLEY UP AGAINST THE WALL AND ADVISED HIM HE WAS UNDER ARREST. OFFICER MANNING SPUN O'MALLEY AROUND AND LEANED HIM AGAINST THE SAME WALL AND APPLIED HANDCUFFS (GAPPED AND DOUBLE LOCKED). SGT BUTCH WAS AT THE BOTTOM OF THE STAIRCASE ABLE TO SEE THE ENTIRE SEQUENCE OF EVENTS.

O'MALLEY WAS ESCORTED OUT TO A POLICE VEHICLE FOR TRANSPORT. DISPATCH ADVISED OFFICER MANNING OVER THE PHONE THAT O'MALLEY SHOULD BE HELD UNTIL THE OTHER RESIDENCES ARE CHECKED FOR THE FEMALE DUE TO A POSSIBILITY OF PHYSICAL HARM. OFFICER MANNING WAS ADVISED OF A PRIOR INCIDENT WHERE THE FEMALE WAS STRANGLER/CHOKED ALLEGEDLY BY O'MALLEY. BUTCH SPOKE WITH ESTHER WHO STATED SHE WAS NOT SURE WHO (HER OR MATHUE) WAS LISTED ON THE LEASE AGREEMENT WITH THE LANDLORD AS THE RENTER. 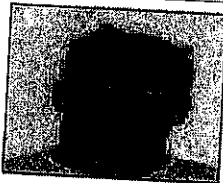

On the above date and time Lei Rivera came to the station and advised that his brother-in-law Mathue O'Malley tried to attack him with a weed whacker because Lie came to the residence to give Mathue's girlfriend a ride home away from Mathue because they just broke up. Mathue's sisters both fear for there safety because Mathue is not acting right and threatened to kill everyone and himself. Lei wanted officers to go to the residence to check on the welfare of Mathue's ex-girlfriend who is unable to leave the residence because Mathue will not leave. D/S Zupko and D/S Taybus went to 81 Tremble and were met outside by Mathue who was yelling for them to get off his property and as if he was going to release the dog. Mathue then went into the house and came back out with a gas can and started to pour gas all over the porch and on a rag.

D/S Taybus advised dispatch to call for assistance from other departments and to call out the Task Force. Eng 2 was dispatched to assist as well. Mathue started to light the rag to set the porch on fire. Mathue made several attempts to light the porch but failed. Mathue's third attempt to light the porch caused a back-draft and the porch was on fire preventing Mathue from entering back into the residence. While Mathue was facing the porch looking for a way back into the house officers grabbed Mathue and placed him in cuffs (gaped and double locked). Eng 2 was en route and advised that the scene was safe. Eng 2 put the fire out and made sure that the residence was safe to go back in. Fire Captain Mrakovich recovered the gas can with suspected gasoline in it as evidence and took (24) photos of the damaged property and evidence. Fire Captain Mrakovich placed a sample of the suspected gasoline in an evidence tube and disposed of the rest of the suspected gasoline for health and safety reasons. D/S Taybus transported Mathue to Mahoning County Jail where he was held with no bond pending his court hearing on March 28, 2016 at 9:00 A.M. Also at this time, neither Mathue's girlfriend or other family members wanted to file a report or sign domestic violence charges on Mathue.

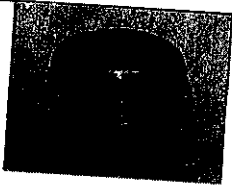

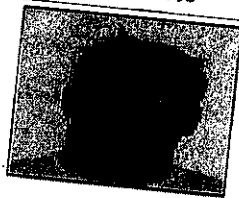

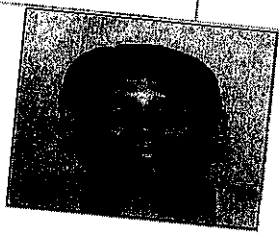

NARRATIVE	<p>On the listed date and time Officers Tedesco, Esposito, and Marco were dispatched to 81 Tremble for a report of a female being held against her will. Police arrived and spoke with the caller, Dezaray Martinez, who stated her cousin, Fantasia Hubbard, was inside the residence and her boyfriend, Mathue O'Malley, was prohibiting her from leaving. Dezeray showed police several text messages stating that Fantasia wanted to leave but O'Malley was beating her, holding her against her will, and telling her to lie saying they were not at the house.</p> <p>Officer Tedesco went to the front door attempting to make contact with O'Malley but got no response. Two dogs were also barking inside the residence but there was no sign of anyone inside the residence other than the dogs. Tedesco then contacted Lt. Sferra in regards to handling the situation. Sferra advised to contact Sgt. Pavlansky and Sgt. Smith and have them take over the scene. A perimeter was set by Tedesco, Esposito, Marco, and a Coitsville police officer.</p> <p>(D/S Pavlansky) Pavlansky arrived on scene and spoke with officers Tedesco, Espisito, and Marco as to what had taken place and any update on the situation. Officers advised Pavlansky that Mathue O'Malley is inside the house with his girlfriend Fantasia Hubbard. Officers further advised that they spoke to a witness who advised that they have text messages from Fantasia stating that she is inside the house being held against her own free will and that Mathue is assaulting her. Tedesco then advised Pavlansky that he spoke to Mathue over the phone and Mathue stated several times that he was not at the residence. At this time Ptl. Manning arrived on scene to assist. Mathue's mother, and homeowner, Esther O'Malley arrived at the residence as well. Pavlansky then advised Esther to contact Mathue, to which she did, and advised that he is in the house. Pavlansky then told Esther that Mathue is commanded to release Fantasia and come out of the residence, to which she conveyed the instructions. Manning then contacted Mathue through cell phone and advised him to release Fantasia and come out of the house. At this time Fantasia came out of the front door to Pavlansky. Pavlansky moved her to safety and asked if she needed an ambulance, to which she said yes. Life fleet was then dispatched to the scene. Pavlansky then questioned Fantasia as to what had taken place. Fantasia advised that Mathue would not let her leave the residence and that he had punched and kicked her. Tedesco then stood by Fantasia until the ambulance arrived and her mother.</p> <p>Soon after fantasia was released, manning was successful in talking Mathue out of the residence. Mathue came out with his hands up, was placed under arrest, and further spoke with Manning in regards to the incident. Pavlansky then requested a search of the basement for any evidence relating to the unlawful restraint and assault. Esther then gave officers permission to search the basement. While checking the basement a strong odor of marijuana could be smelled and a marijuana "blunt" and scale were observed in plain view. Being that Mathue is known to abuse drugs and be in possession of weapons, Pavlansky requested that Esther give officers consent to search the residence. Esther then agreed and signed a "Consent to Search Auto/Premises" form given by Ptl. Vukovich.</p> <p>Officers then searched the residence and photographed and logged all listed evidence. Tedesco and Marco remained on station and spoke to the witnesses Dezaray Martinez and Sierra Gayles who each provided a written voluntary statement. Esposito transported Mathue to station where he was booked and subsequently transported to the Mahoning County Sheriff's Office.</p>

OFFICERS THEN PLACED O'MALLEY IN THE REAR OF MARKED UNIT #111 UNTIL FURTHER INVESTIGATION INTO THE INCIDENT. On 08/12/2023 I, officer Wharry working YPD car 105 was SVR to [REDACTED] in ref a fight between a male and female. Upon arrival I spoke to [REDACTED] (victim) who stated the following;

Earlier today, she had an altercation in Campbell with her child's father and current boyfriend Mathue O' Malley. She advised she was at his residence at 81 Trumble when a fight ensued. [REDACTED] further stated CPD responded and escorted Mathue from the property. A short time later she returned to her home where she found O' Malley damaging her electric meter attached to her home. While still in her vehicle a red Chevy Bearing OH [REDACTED] Mathue grabbed her by her neck in an attempt to choke her. She was able to get separated from him without being harmed. At this time Mathue used a yellow metal rod to smash the front and drivers side windows of her vehicle causing glass to shatter throughout the inside of her car that she and her (4) children were currently in. Mathue then fled scene prior to my arrival. Mathue is described as light skin around 5'10" with dark curly hair. Mathue is currently driving a light blue Saturn.

[REDACTED] stated this was not the first time he has attacked her and she was in fear for her family's safety. [REDACTED] completed and signed a YPD PD-6 domestic violence form. She was issued copy of PD-6 and advised to contact YPD SVU on 08/14/2023 at 0830hrs to follow up with charges. [REDACTED] advised she does have family she could stay for a short time. I did not observe in marks, scratches or bruising on [REDACTED] at time of report. She was advised to contact police if O' Malley returned.

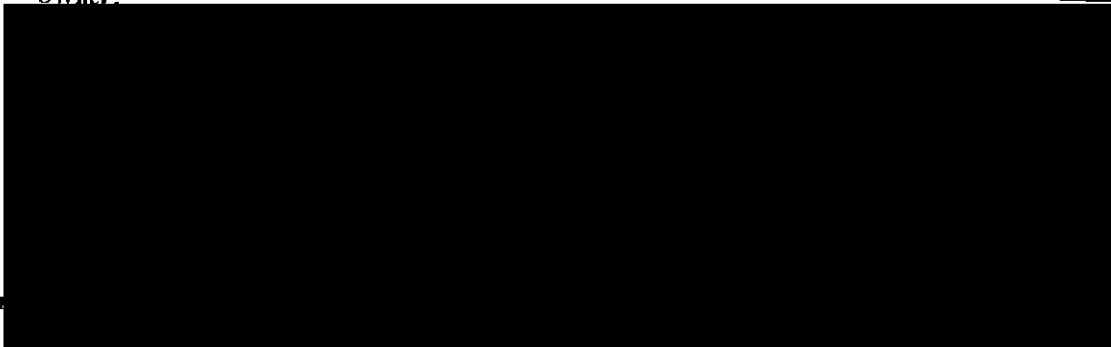

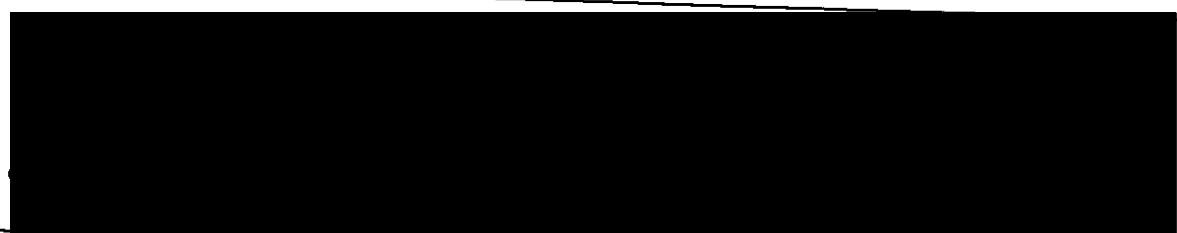

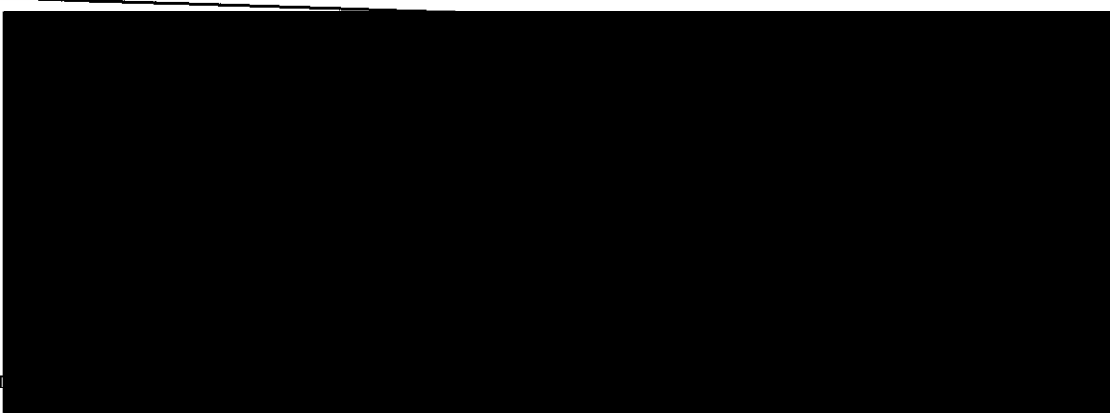

On 01-29-20 at 1126 hrs, Cars #103 Villio, #109 Rivera and #106 Hassey svr to the area of Crandall/Belmont ref. a male in a gold Jeep just shot out the window of a white Olds Bravada. En route officers were advised the victim later ID'ed as [REDACTED] went to Mercy Health at 1044 Belmont and the suspect later ID'ed as O'Malley, Mathue was in the Crandall/Belmont area. Officers checked the area of Belmont/Crandall for the suspect auto with negative results. Upon arriving at St. Elizabeth's Hospital the 2003 white Olds Bravada bearing OH. 725ZBN was observed with heavy front end damage and a shattered rear windshield. Officers observed Victim #1 [REDACTED] with a dark bruise around her right eye and swelling. She advised on 01-28-20 at approx. 0700 hrs. she was at her home at 811 Crandall when the father of her unborn child O'MALLEY, MATHUE struck her with a closed fist in the head and body and kicked her causing the visible injury. I also observed scratches and bruising to her chest area. She advises she had just broken up with him and he was angry over that. She did not call the police at the time of the assault. On this date at 1100 hrs, she advised she and her dad arrived at her house at 811 Crandall and he was inside. She was gathering her belongings to leave and when she was outside her purse spilled on the ground causing her unk. make .38 pistol to fall from her purse and he grabbed it as she and her dad were hurrying into the car and he fired (1) round into the rear window of the auto causing it to shatter. He also kept cutting them off causing her dad to hit the rear of his auto., the gold Jeep Cherokee he was driving and fled the area. Off. Crissman from the Crime Scene Unit arrived and took photos of victim's injuries and the damage to the car. A PD-6 was completed and signed by the victim. Victim was advised to follow up with FISU as well as call 911 if she observed the suspect. Check of the suspect via Spillman further reveals he is currently on parole. At approx. 1305 hrs. Car #106 Hassey observed a 2009 gold Cherokee in the lot of Gaetano's Pizza on McCartney Ave. bearing HDR2739 returning to the suspect's sister. Car #106 Hassey, #104 Miller and Sgt. 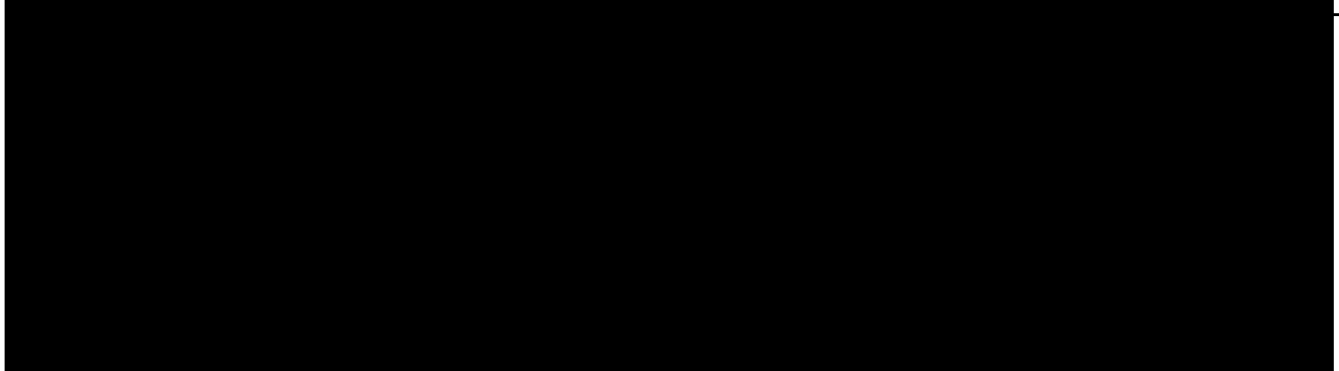
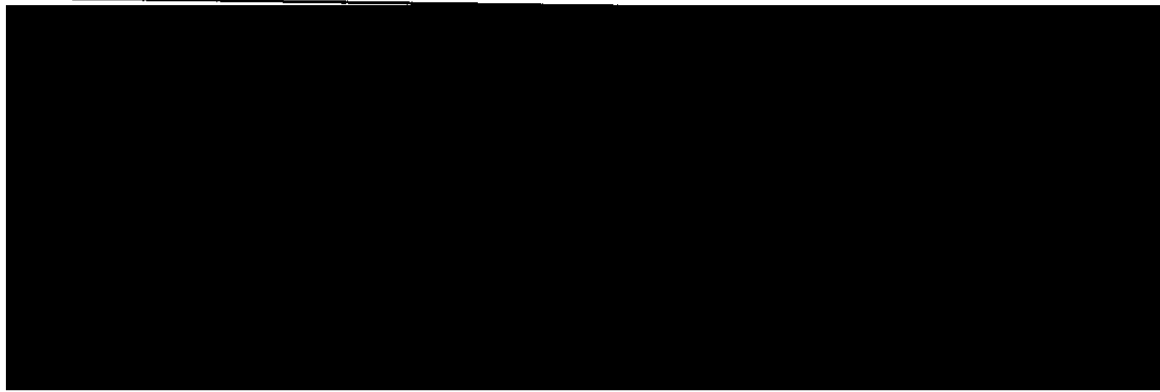

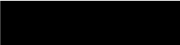

A PD-6 was completed and victim was given a copy and advised to follow up with FISU. Search of the area for the suspect O' MALLEY, MATHUE came up negative.

Narrative

On 06-01-21 at approx. 1700hrs Cars 109 Officer M. Quinn and [REDACTED] were SVR to [REDACTED] ref. a fight. Upon arrival Officer were met by a male later identified as O' MALLEY, Mathue who was loading an infant child into a car seat in his truck. While this was occurring a female later identified as [REDACTED] came out of the home and stated he cannot take my child, which was later found to be their child in common. During this Mr. O' MALLEY then turned the child back over to [REDACTED] and they began to argue about her keys and phone, which Mr. O' MALLEY stated he did not have. After a short time of speaking with both individuals MR. O' MALLEY entered his vehicle and left the scene.

While I was still attempting to ascertain what occurred Mr. O' MALLEY returned to the house at which point he threw [REDACTED] s phone on the front porch, and then left again. While speaking with [REDACTED] I observed a large red bump on her forehead. [REDACTED] at that time advised that Mr. O' MALLEY had come to her house, which he stays at from time to time, and began to argue with her daughter ref. a social media post. During this [REDACTED] became involved due to him speaking to her daughter(not his child) and a physical altercation took place between [REDACTED] and Mr. O' MALLEY. [REDACTED] advised that during the altercation MR. O' MALLEY struck her with a closed fist which caused the bump on her forehead.

After gaining all the facts of the incident and while [REDACTED] was filling out a YPD PD-6 Domestic Violence Form, MR. O' MALLEY again returned, at which time myself and [REDACTED] were able to effect an arrest on him, which he was handcuffed, and placed in marked cruiser [REDACTED] Car 101 D/S Gaitanis was summoned to the scene to take pictures of Ms. [REDACTED] injuries, which he arrived a short time there after and took several photos of Ms. [REDACTED] injuries. Ms. [REDACTED] did complete and sign the above mentioned YPD PD-6, given a copy and advised on how to pursue this further with our F.I.S.U. Division. [REDACTED] then transported Mr. O' MALLEY to the M.C.S.O. free of injury and in apparent good health. Mr. O' MALLEY was logged into the M.C.S.O. where he will be housed pending court on 06-02-21 in Youngstown Municipal Court for Domestic Violence ORC. 2919.25 M-1. A copy of the YPD PD-6 was later placed in YPD Desk area to be attached to this report.

Narrative

On 09-19-21 at 1057 hrs. Cars #103 Villio and #105 Blaine as well as #109 Rowley svr to [REDACTED] ref. fight called in by the stepdaughter. The call was made by [REDACTED] [REDACTED] who advised that her stepdad was beating on her mother. Upon arrival officer's heard yelling as we pulled up on the street. We went in the home and observed O' MALLEY, MATHUE kneeling on the floor in front of the mother of his child [REDACTED]. She was visibly upset and kept asking him to leave. Officer's separated the two and I observed the right side of her face near her cheek and forehead to have bloody scratches and swelling as well as multiple scratches on both her arms, shoulders and the left side of her neck. She advised that they were arguing upstairs and she kept telling him to leave because the kids were scared due to their violent history. She further advised he was holding her down on the bed to keep her from getting up and punched and pushed her multiple times causing her injuries. O' MALLEY, Mathue was handcuffed and patted down without incident and advised that he was under arrest for Domestic Violence and placed in the rear of Car #105. A supervisor was requested to photograph her injuries, but was unavailable due to a natural death at another location he had to attend to. I have in the last year made reports and arrests of the suspect for Domestic Violence with the same victim. She advises he was convicted of Domestic Violence so he was charged with a Felony. It should be noted that she was issued a CPO against the suspect in June of 2021, but she freely admitted to allowing him back to the home as she needed help with their child. She completed a PD-6 and was given her copy and advised to follow up with FISU in the A.M. before his arraignment.

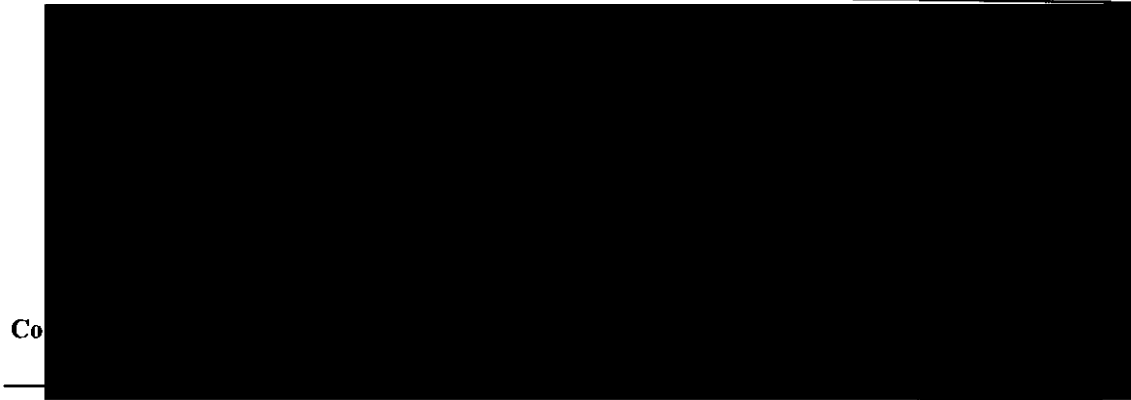

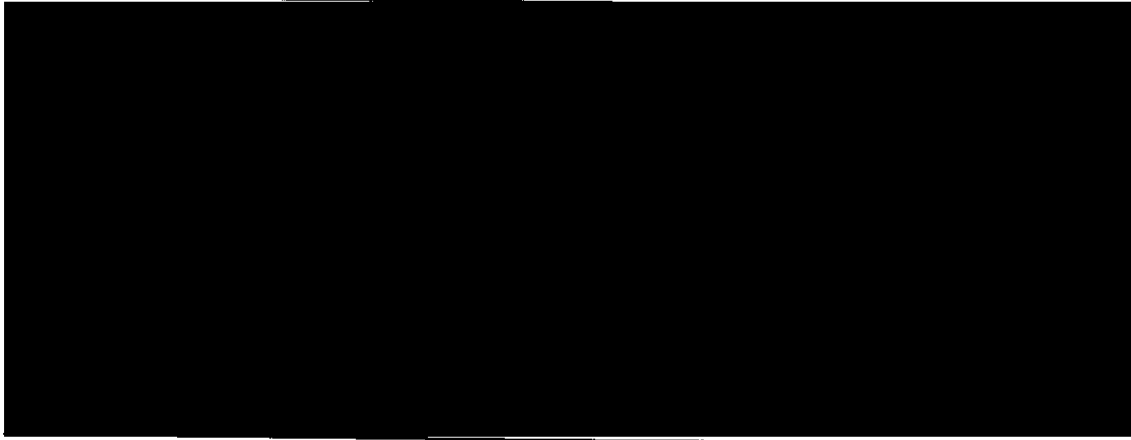

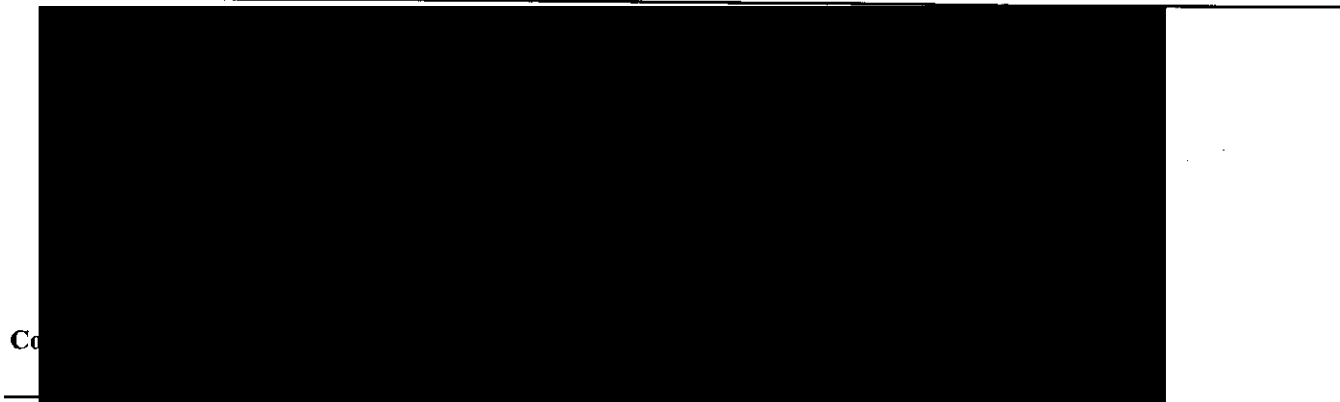

Narrative

On 4/10/22 I, Officer Garling, in car 103 along with car 105 Officer Congemi, were SVR to [REDACTED] in reference to an investigation. Upon arrival, I spoke with [REDACTED] who reported the following:

At about 2200 hrs, she observed her ex-boyfriend and child's father, Mathue O' MALLEY, walking from the area of the passenger side of her father's GMC Suburban OH ([REDACTED]). Further, she observed the vehicle to be lowering. She told O' MALLEY to leave and that she had called the police. O' MALLEY left at this time, but she did not actually call the police. She sent her daughter to the vehicle to investigate it and discovered both tires on the passenger side flattened. About twenty minutes later (approx 2220 hrs), O' MALLEY returned and was throwing rocks at her bedroom window. At this time, she did phone the police and O' MALLEY left prior to the arrival of police.

I observed the tires to be flat and during my interview of [REDACTED] her phone rang several times with "no caller ID". She advised this was O'MALLEY and then answered the phone to prove it to me. I let O' MALLEY speak for a moment. He talked very quietly, but I could hear him saying he wanted to come over and wanted to see the kids and for her to let him inside.

[REDACTED] explained she is very afraid of O' MALLEY. She stated if he was alone with her in a room, he would leave her with bruises and cover her mouth to keep her quiet. [REDACTED] stated he has not threatened her at this time and she will seek a protection order.
