Narrative:

On Friday, November 17, 2023 at 1200 hours, Ohio Attorney General's – Bureau of Criminal Investigation (BCI) – Special Agent Charlie Snyder (Snyder) arrived at the Cuyahoga County Medical Examiner's Offices (CCME) located at 11001 Cedar Avenue, Cleveland, Ohio 44106. Snyder subsequently meet with CCME Evidence Custodian Astra Driscoll and received the following autopsy/evidence items:

- one large manilla envelope, marked with "IN2023-2006", with labeling "Lab Case Number 2023-008924...", that contained
- eleven smaller manilla envelopes, containing twelve items of recovered evidence indicated as:

 - Item #035 – Projectile – whole
 - Item #036 – Projectile – whole

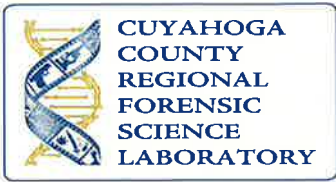




