Officer Involved Critical Incident - Sheena Dominique Doumbouya (V)

Investigative Activity: Processing of Law Enforcement (*Scene 2*)
Activity Date: March 7, 2022
Activity Location: Franklin County Sheriffs Office, 3rd Floor, Columbus, OH

On March 7, 2022, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Franklin County Sheriff's Office (FCSO) reference an officer involved critical incident. It was reported that four members of the FCSO Special Investigations Unit intervened in an active assault in the Franklin County Parking garage at 34 E. Fulton Ave in downtown Columbus. BCI was advised that during the incident, Rayshawn Meeks obtained a firearm from one of the deputies and shot himself in the head. Special Agent Supervisor (SAS) Joshua Durst responded to the main scene and Special Agent (SA) Mathew Austin responded to the Franklin County Sheriff's Office administration building where the involved Deputies were stationed. SA Austin arrived on scene at approximately 1135 hours.

██████████ a plain clothes deputy, was observed to have some slight staining on the knees of her jeans. Deputy ██████████ advised her firearm was secured in a vehicle during the incident and she was found to not be armed at the time.

D. Feery, a uniformed deputy, was found to have no injuries or damage to his uniform. An empty pouch was documented on the right/front side of his external vest carrier that he reported was where his Taser was carried. Feery advised that another deputy deployed his Taser and was still in possession of it. Deputy Feery's firearm, a SIG P226 was found to be loaded with a cartridge in the chamber with a full magazine of 9mm Luger WIN. His two other magazines were also found to be full.

██████████ a plain clothes deputy, was found to have no injuries or damage to his clothing. Deputy ██████████ advised his firearm was secured in a vehicle during the incident and he was found to not be armed at the time. Deputy ██████████ was in possession of a paper bag which he reported contained a Taser that he took from Feery and deployed during the incident. The yellow Taser with markings of "██████████" and "██████████" contained an unfired 25' cartridge in its base and they were collected together as item #2.

██████████ a plain clothes deputy, was found to have staining and suspected blood on the knees of both of his jeans. Deputy ██████████ also advised his left shoe was scuffed and that his right cheek was injured during the incident. SA Austin documented these areas through photography and used a scale to further photograph two linear abrasions on his right cheek. Deputy ██████████ was found to have an empty black plastic/kydex holster with a battery taped to the back on his right hip (item #1). Deputy ██████████ consented to provide a buccal swab (item #4).

SA Austin was provided a taped paper bag by Deputy Tyler Hartley who advised that after the incident, he met with the involved deputies on the 9th floor of the parking garage. Deputy Hartley reported that he witnessed Deputy ██████ remove his firearm from a holster on his right hip and unload it (removing both a chambered cartridge and a magazine) and place it into the bag. SA Austin located a pistol, magazine, loose cartridge, and fired cartridge casing inside the sealed paper bag. The semi-auto 2011-style Staccato P 9mm pistol (S/N- ██████ with a Holosun green dot optic was packaged separately as item #3. The fired casing (9mm Luger WIN) was placed into an envelope and packaged together with the loose cartridge and magazine containing 18 cartridges as item # 3.1.

SA Austin released these items to SAS Durst while on scene and cleared the area at approximately 1540 hours.
