DEAR SIR: You have submitted for my examination and approval a canal land lease in triplicate, executed by you as Superintendent of Public Works to Hal W. Goodman and Eva Goodman of Portsmouth, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of six dollars, there is leased and demised to the lessees above named the right to occupy and use for residential and agricultural purposes that portion of the abandoned Ohio Canal lands located in Morgan Township, Scioto County, Ohio, which is more particularly described as being the full width of the bed and embankments of said canal property, beginning at Station 2067, and running thence southwesterly with the lines of said canal property 100 feet to Station 2068, and containing 11,500 square feet of land, more or less.

This lease is one executed by you under the authority of an act of the 79th General Assembly providing for the abandonment of the Ohio Canal from Buckeye Lake to Portsmouth and for the sale and lease of parcels of the canal land so abandoned. 102 O. L., 293. Upon examination of this lease, I find the same to be in conformity with this act of

the legislature and all other statutory provisions relating to leases of this kind. The lease has been properly executed by you as Superintendent of Public Works and as Director of said Department and by the lessees above named. I am, accordingly, approving this lease as to legality and form as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith enclosed.
