### Narrative:

On October 30, 2023, at about 1515 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) met with Karen Fisher (Fisher) at her residence. Fisher explained that she installed home surveillance cameras at her mother's, Delaine Koelliker (Koelliker), residence due to Koelliker's dementia and advanced age. Fisher said she had two videos from the evening of October 3, 2023, when the incident and shooting occurred. One of the videos was on her phone and one of the videos was in a Google Drive link that she received from her sister, Linda Schall (Schall).

The video on Fisher's cell phone was very short. It did not record the incident nor the shooting. Fisher sent that video to SA Moran's BCI cell phone.

The video in the Google Drive link sent by Schall was accessed via Fisher's Apple MacBook laptop. SA Moran directed Fisher to download the video to her laptop. The video was copied to media and was copied to SA Moran's BCI laptop.

The video files SA Moran obtained were labeled:

- RLGC7281 (from Fisher's cell phone)
- 1000001909 (from Google Drive link sent by Schall)

SA Moran reviewed the videos and noted the following:

### RLGC7281

This video file was six seconds (00:06) long. The exterior camera angle was facing south and into Koelliker's backyard. It did not have a field-of-view that covered the area where the shooting incident occurred. The timestamp embedded with the video was "10/03/2023 22:34:14" at the beginning of the video. The video showed officers walking west through the backyard. It also showed officers standing near Koelliker's garage at the rear of her property. There was no audio heard with the video file. The



This video file was 10 minutes and 53 seconds (10:53) long. There was no embedded timestamp with the video. The interior camera angle covered Koelliker's living room. It did not have a field-of-view that covered the area where the shooting incident occurred.

At about the 07:41 video mark, Koelliker was heard yelling, "They're shooting at the house." She was out of view of the camera.

At about the 10:02 video mark, Koelliker said, "Call the cops please." She had been screaming and yelling various remarks prior to this statement.

It did not appear that the video files needed any further video analysis since the shooting was not captured on the video stream nor audio stream.

The video files were uploaded to Evidence.com under case number 2023-2639 and were placed in a folder labeled as Reference Item A. The video files were also copied to a DVD-R and were placed in the BCI SIU case file and labeled as Reference Item A.

### **Reference Item:**

A. Two video files labeled RLGC7281 and 1000001909 were copied to a DVD-R and placed in the BCI SIU case file, and labeled as Reference Item A.
