Narrative:

On Monday, September 08, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joe Lamping (SA Lamping) received video footage from Ohio State Highway Patrol (OSHP) Lt. Daniel Jesse. SA Lamping was informed that the videos contained footage from the dash cameras recorded by [REDACTED]. The involved officers, and witness officers, provided consent for investigators to review any conversations captured on video with their supervisors. SA Lamping reviewed the video recording and noted the following:

[REDACTED] dash camera started at approximately 14:44:28 and was 1 hour 27 minutes and 27 seconds in length. The first frame of the dash camera is displayed below:

No audio is present until approximately 14:45:57. When the audio is activated, the sound of a revving engine and siren can be heard while [REDACTED] was driving. OSHP dispatch is able to be heard during the video, and they were providing troopers with updates on the pursuit that the Ashtabula County Sheriff's Office (ACSO) was involved in.

A selection of what SA Lamping deemed to be the most pertinent updates provided to troopers by OSHP dispatchers are documented in the table below:

Time	Update from OSHP Dispatch
14:46:22	"It is gonna be a red motorcycle"
14:46:57	"He's throwing the baggies out of the motorcycle"
14:48:58	"Up to 75 miles per hour, just passing Maple"

At approximately 14:54:22 [REDACTED] advised, '[REDACTED] I'm behind 'em, they're East on Fink.' The image below was taken from [REDACTED] dash camera at approximately the same time frame. A dark SUV, presumably belonging to the ACSO is observed on a side road, the yellow highlight was added to assist in identifying the vehicle:

[REDACTED] turned onto the side road from the above picture and assisted in the pursuit. The chart below contains what SA Lamping deemed to be the most pertinent updates from [REDACTED] while he was engaged in the pursuit:

At approximately 15:04:39 a series of loud percussive sounds, consistent with gunshots, is heard on the dash camera. Nothing of note is observed within the camera's field of view. The noises ceased at approximately 15:04:42. While [REDACTED] vehicle was unoccupied, various radio traffic was overheard. The OSHP radio traffic was documented in a separate report, and as such is not documented in this investigative report unless otherwise deemed relevant by SA Lamping.

At approximately 15:04:58 ACSO [REDACTED] was observed returning to his vehicle with [REDACTED], pictured below:

ADDITIONAL FACTORS FOR EVALUATING THE VIDEO RECORDINGS

There are numerous other factors that need to be considered when reviewing and evaluating the videos and audio recordings of this incident. Those factors are:

- A.** Video recording devices record within the video and sound capabilities available, and they record objectively. Video recordings lack the history, perspective, and interest of the people involved. The positions, angles, obstacles, lighting, and distance from the incident are also factors that need serious consideration.
- B.** Video recording devices also record more information about a particular scene or incident than the person(s) involved in the incident can process during the critical incident. Video recording devices rarely record an event from the same perspective of the officer. It captures the action but not the perception, decision making, focus, or intent of the officer. Video recordings often miss tactile cues or other actions of a subject.
- C.** The speed of the incident is remarkable. The speed and complexity of rapidly evolving situation(s) that occur during use of force encounters are difficult concepts to comprehend by only watching the video.

The dash camera footage was stored on Axon Justice as part of Reference Item E – BWC Dash Videos where it can be reviewed in its entirety.
