On Tuesday, January 9th, 2024, the Lawrence County Sheriff's Office (LCSO) requested the assistance of the Ohio Bureau of Criminal Investigation (BCI) Crime Scene Unit (CSU) and Special Investigations Unit (SIU) for an officer involved critical incident at the above listed activity location. It was reported that LCSO was dispatched to a domestic dispute where a male was holding a weapon to a female's (**Constitution**) throat. LCSO gave orders to the male, identified as Skylar Corbin (Corbin), to drop the weapon. When Corbin did not obey said orders, LCSO the weapon, striking Corbin. Corbin was transported to Cabell Huntington Hospital in Huntington, West Virgina. At approximately 2115 hours, Special Agent Supervisor Joshua Durst assigned CSU Special Agent (S/A) Aja Chung and S/A Sarah Taylor to the investigation. It was determined BCI SIU would lead the investigation and BCI CSU would process the scene.

S/A Chung arrived at 9714 SR 93 at approximately 0015 hours on January 10th, 2024. At that time, she was briefed by lead SIU S/A Chad Holcomb and was advised the search warrant was signed. The scene was contained to the front yard of the residence near the wheelchair ramp to the trailer. The inside of the residence was documented through photography. S/A Chung further documented the scene with a 3D scanner. S/A Chung requested S/A Sarah Taylor respond to 111 South 4th Street, Ironton, OH 45638 (Lawrence County Courthouse) to document LCSO

S/A Chung observed a yellow flag at the end of the wheelchair ramp that marked a casing. The .40 caliber casing was collected as item 1. A tire awl (item 2) was located on the grass near some suspected bloodstains. The tire awl was reported to be the weapon Corbin held to **Second Second** throat. S/A Chung was advised LCSO **Second** s weapon was collected prior to BCI arrival and secured in cruiser 31. S/A Chung received two paper bags from LCSO Sergeant Jason Newman. One bag contained four (4) fully loaded spare magazines and the other bag contained **Second** s pistol. The paper bag that contained the four (4) fully loaded spare magazines were photographed for documentation only and returned to LCSO Sergeant Newman. The pistol was removed from the paper bag and found with the slide locked back, one loose cartridge and one loose magazine. The pistol was a Glock 22, .40 caliber semi-automatic pistol with serial number: **Second** and a TRL-1 Streamlight tactical light

attached. 14 cartridges were removed from the magazine (capacity of 15). The pistol, magazine, 15 cartridges, and original packaging were packaged together as item 3. S/A Chung received two cell phones from S/A Holcomb. Cell phone was collected as item 4 and a cell phone that belonged to Donna Gullett was collected as item 5. The cell phones were erroneously not photographed.

After the scene at 9714 SR 93 was processed and no other items of evidentiary value were located, S/A Chung traveled to Cabell Huntington Hospital located at 1340 Hal Greer Boulevard, Huntington, WV 25701. For ease of documentation, the hospital was labeled "Scene 2". There S/A Chung collected Corbin's clothing and cell phone at approximately 0310 hours. The clothing (jeans, sweatshirt, t-shirt, long john thermals, underwear, red athletic shorts, two belts, a pair of boots and socks) was photographed and collected as item 1. The Samsung cell phone with a cracked screen was collected as item 2. S/A Chung cleared the hospital at 0345 hours.

S/A Chung drove to BCI Offices in London, Ohio and did the following:

- Placed items 2, 4 and 5 from scene 1; and items 1 and 2 from scene 2 in BCI evidence locker #2 at 0705 hours.
- Items 1 and 3 from scene 1 were submitted to the BCI Laboratory at 0730 hours.
