Comments: Case Synopsis: On 12/05/2024, a Canton Police Department officer was notified of a male that pointed a gun at another

person. The CPD officer located and pursued the subject. The subject had his hand in his jacket pocket during the foot pursuit. The subject (Zachary Fornash) began to remove his hand from his jacket, thereby partially exposing what appeared to be a pistol. CPD officer fired several shots striking and killing Zachary Fornash. A pellet gun was located

near Fornash.
