LEASE—RESERVOIR LAND, STATE WITH P. E. RUTHERFORD, DESIGNATED LAND, LOTS NUMBERS 14 AND 15, BUCKEYE LAKE, FAIRFIELD COUNTY.

DEAR SIR: You have submitted for my examination and approval a certain reservoir land lease in triplicate, executed by the State of Ohio, through you as Commissioner of the Division of Conservation and Natural Resources to P. E. Rutherford of Columbus, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$18.00, there is leased and demised to the lessee herein named, permission to occupy and use for lawn, walkway and

docklanding purposes only, the State land and water frontage in front of lots numbers 14 and 15 in Clymers' Subdivision of Lots at Buckeye Lake, and being in the Southwest Quarter of Section 27, Town 17, Range 18, Fairfield County, Ohio.

Upon examination of this lease, I find that the same has been properly executed by you as Commissioner of the Division of Conservation and Natural Resources and by said lessee. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.
