Narrative:

On May 30, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Perry Roeser received several handwritten witness statements from the Union County Sheriff's Office and the Marysville Police Department. Uniformed officers conducted a neighborhood canvass before BCI arrived at the Officer-Involved Critical Incident (OICI) on Meadowlark Lane, Marysville, Ohio.

SA Roeser reviewed all the witness statement forms and found that none of the witnesses observed the OICI. The witness statements (attachment #1) have been uploaded and can be reviewed for additional details.
