## APPROVAL, FORM OF REFERENDUM UNDER S. B. 204, 90th GENERAL ASSEMBLY.

DEAR SIR:—You have submitted for my examination a written petition signed by one hundred qualified electors of this state, containing a measure to be referred and a summary of the same, under Section 4785-175, General Code.

It is proposed to refer to the electors of this state Amended Senate Bill No. 204 of the 90th General Assembly, entitled "An act to provide for a convention to pass on amendments to the constitution of the United States which may hereafter be proposed by the congress for ratification by conventions in the several states."

The summary of this measure to be referred reads as follows:

"Amended Senate Bill, No. 204, provides for a Convention to pass on Amendments to the Constitution of the United States which may hereinafter be proposed by the Congress for ratification by Conventions in the several states.

It sets forth that when the Congress of the United States proposes such a Convention, the Governor shall fix the date of election for delegates. At such elections all qualified voters shall be entitled to vote. Such election, shall be conducted and results thereof ascertained and certified in the manner as in the case of Presidential electors in this state. All election laws being made applicable except such as are inconsistent with this Act

It further provides that 52 delegates shall be elected from the state at large, and sets forth the qualifications of candidates for such office and the manner in which the delegates shall be nominated and elected. It further provides for nomination of 52 nominees favoring ratification, 52 against ratification, and 52 nominees to remain unpledged.

Nomination papers and acceptances are to be filed with the Secretary of State. The Bill further provides that election shall be by separate ballot and the manner in which same shall be prepared.

The Bill provides for the filling of vacancies among the delegates, the time at which such Convention shall be held, and the manner in which the work of the Convention shall be conducted.

It provides for the certification of the result of the vote of the delegates, and for payment of the mileage of the delegates to the Convention to be held in Columbus, Ohio. The Bill further provides that any further action by Congress directing a different course of procedure than that provided in the Bill shall take precedence over these provisions, thus nullifying same, and authorizing state officials to act under such new provisions and in obedience thereto."

I am of the opinion that the foregoing is a fair and truthful statement of the measure to be referred and accordingly submit for uses provided by law the following certification:

"I, John W. Bricker, Attorney General of the State of Ohio, pur-
