## Narrative:

On Friday, October 20, 2023, at 0931 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) responded to the Cuyahoga County Medical Examiner's Office (CCMEO) to retrieve the items of evidence from the autopsy performed on the decedent Ricco Acevedo.

SA Goudy received eighteen (18) items from CCMEO evidence technician Megan Gates to be placed into evidence. Eight swabs, one gunshot residue examination, six personal items of clothing, one blood stain card, reference public hair, and one whole projectile removed from the decedent's back. These items were placed into temporary evidence locker #40.
