DEAR SIR: I am in receipt of a communication from the Chief of the Bureau of Inland Lakes and Parks of the Division of Conservation, in your department, requesting my approval of a certain reservoir land lease in triplicate, executed by the Conservation Commissioner to one W. Herbert Dailey, of Columbus, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$24.00, there is leased and demised to the lessee above named, the right to occupy and use for cottage site and docklanding purposes, forty-nine feet as measured along the top of the outer slope of the embankment (northerly) of Buckeye Lake, and having a frontage of 37.4 feet along the State Highway located immediately north of the borrow pits.
