APPROVAL—CONTRACT BY AND BETWEEN THE STATE OF OHIO ACTING IN BEHALF OF THE BOARD OF TRUSTEES OF KENT STATE UNIVERSITY AND HARRY A. FULTON, ARCHITECT, PLANS AND SPECIFICATIONS FOR RECEIVING AND STORAGE SHOP, ETC.

DEAR SIR: You have submitted for my approval a contract by and between the State of Ohio acting by the Director of Public Works, on behalf of the Board of Trustees of Kent State University, and Harry A. Fulton, an Architect of Cleveland, Ohio, for the preparation of plans and specifications for a new Receiving and Storage Shop and changing the Pumping Equipment and Electrical Construction in said connection, which contract calls for a total remuneration to the Architect to be five and one-half per cent ($5\frac{1}{2}\%$) of the amount paid out by the State of Ohio under and on account of contracts entered into by the State for the construction of said improvement.

You also submitted a copy of the Controlling Board's release of July 6, 1937, and Encumbrance Records Nos. 2170, 2172, 2174 and 2176.

Finding said contract in the proper legal form, I have this day noted my approval thereon and return the same herewith to you, together with all pertinent papers submitted in this connection.
