Special Agent Chris Hamberg (SA Hamberg) of the Ohio Bureau of Criminal Investigation (BCI) requested the Auglaize County Prosecutor's Office to send a subpoena to Verizon Wireless for the cell phone number (773-414-6930) that belonged to Berry.

SA Hamberg received the information back from Verizon Wireless in regard to the subpoena on September 11, 2023. SA Hamberg sent the records to Criminal Intelligence Analyst Beth Dailey (Analyst Dailey).

The subpoena is attached to this report.

In reviewing the records and the report that Analyst Dailey made, the data showed that Berry and his sister, Twana Berry (Twana), had spoken with each other on September 2, 2023, around 1541 hours, and again from 1933 hours to 1944 hours. The records further showed that on September 3, 2023, at 1343 hours, Berry contacted Twana and they were on the phone for approximately two minutes and 51 seconds, and Twana contacted Berry at 1350 hours and they were on the phone for approximately 12 minutes and 29 seconds. At 1406 hours, Twana called Berry and they were on the phone for approximately 13 minutes and 54 seconds.

The Verizon Wireless records coincided with what Twana told SA Hamberg when she was interviewed over the phone on September 5, 2023. For further please refer to IR-3, titled Interview with Twana Berry.
