Narrative:

On Monday, April 4, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Arvin Clar (Clar) and SA Jack Shea attended the post/autopsy of James Sheets (Sheets), involved subject involved in the officer-involved incident that occurred in Youngstown, Ohio, on April 2, 2022.

The autopsy was conducted at the Cuyahoga County Medical Examiners Office (CCME), located at 11001 Cedar Ave., Cleveland, Ohio.

The autopsy was performed by Dr. Todd Barr (Barr) and was assisted by Pathology Assistant Izzy.
