Narrative:

On Friday, February 21, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) received video footage from Akron Police Department (APD). SA Lieber was informed that the videos contained footage from the dash and body-worn cameras (BWC) recorded by the officers involved in and/or responding to the officer-involved critical incident on February 17, 2025 at 294 Ira Avenue, Akron, OH 44301.

SA Lieber reviewed the video recordings and noted the following:
