Narrative:

On July 17, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Harasimchuk (Harasimchuk) reviewed the previously requested and received drone video surveillance footage from the Ohio State Highway Patrol (OSHP).

SA Harasimchuk received and reviewed the following files:

- **1-UAV is shot at**
- **4-UAV inside hallway suspect closes bedroom door**
- **6-Video in room after the explosive breach**
- **7-Inside bedroom and adjacent room after explosive breach**
- **8-UAV flight around condo after explosive breach**
- **DJI_0008**

SA Harasimchuk reviewed the drone video footage and only documented the information believed to be relevant to this investigation. It should be noted that the provided clips contained only video footage, there was no audio.

1-UAV is shot at

This video clip was 4 minutes and 44 seconds in duration (Image #1). At approximately 1 minute and 24 seconds into the video clip the drone entered into what appeared to be a bedroom. An individual can be observed on top of the bed. At approximately 1 minute and 30 seconds into the video clip a possible muzzle flash can be seen (Image #2). The drone then exited this room. The drone then reentered the room. At approximately 1 minute and 38 seconds into the video clip a second possible muzzle flash can be seen (Image #3).

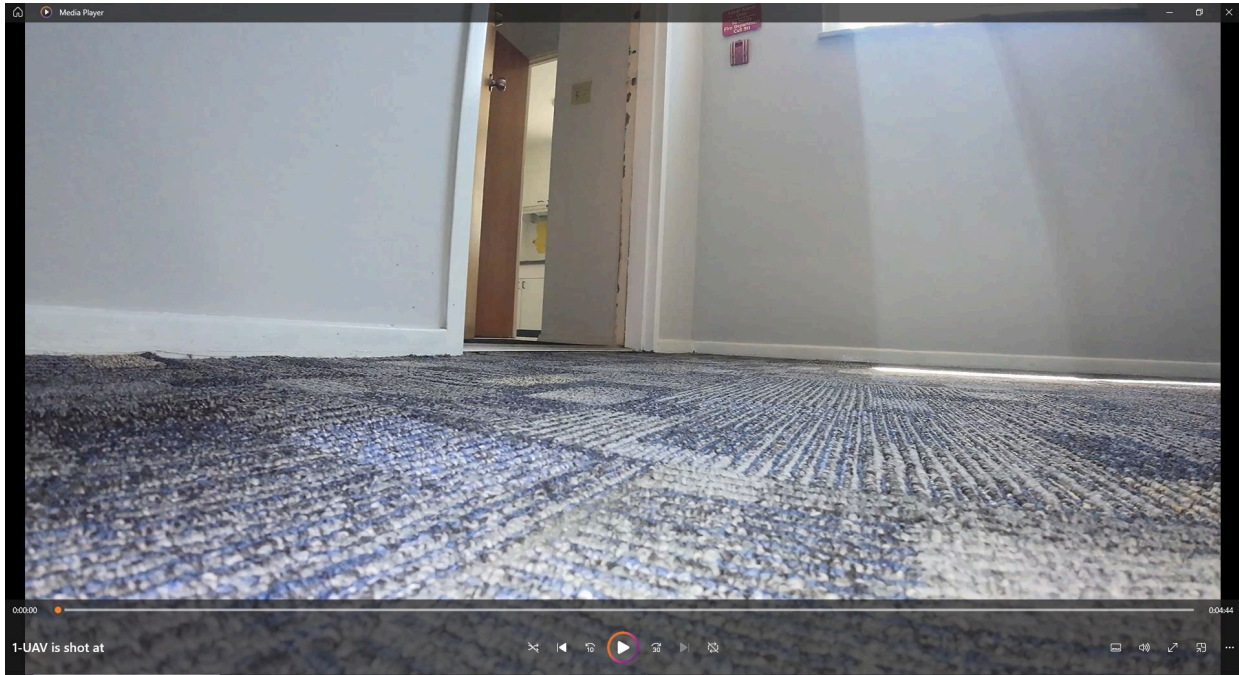

4-UAV inside hallway suspect closes bedroom door

This video clip would not play. On August 13, 2024, SA Harasimchuk spoke with Ohio State Highway Patrol (OSHP) Trooper Colin Acciavatti (Acciavatti), regarding this video clip. Trooper Acciavatti attempted to play the OSHP saved copy of this video, and it would not play. Trooper Acciavatti advised SA Harasimchuk that a working copy of this video clip could not be located.

6-Video in room after the explosive breach

This video clip was 4 minutes and 28 seconds in duration (Image #5). At approximately 1 minute and 1 second into the video clip the drone is in what appeared to be a bedroom, and the bed can be seen lying on its side (Image #6). As the drone continued to fly around the room and an open door can be seen that led into a closet and there was a closed door next to the closet (Image #7). Behind the closed door was the bathroom for this room. As the drone continued to fly around the room multiple defects can be seen in the ceiling, walls and curtains (Image #8).

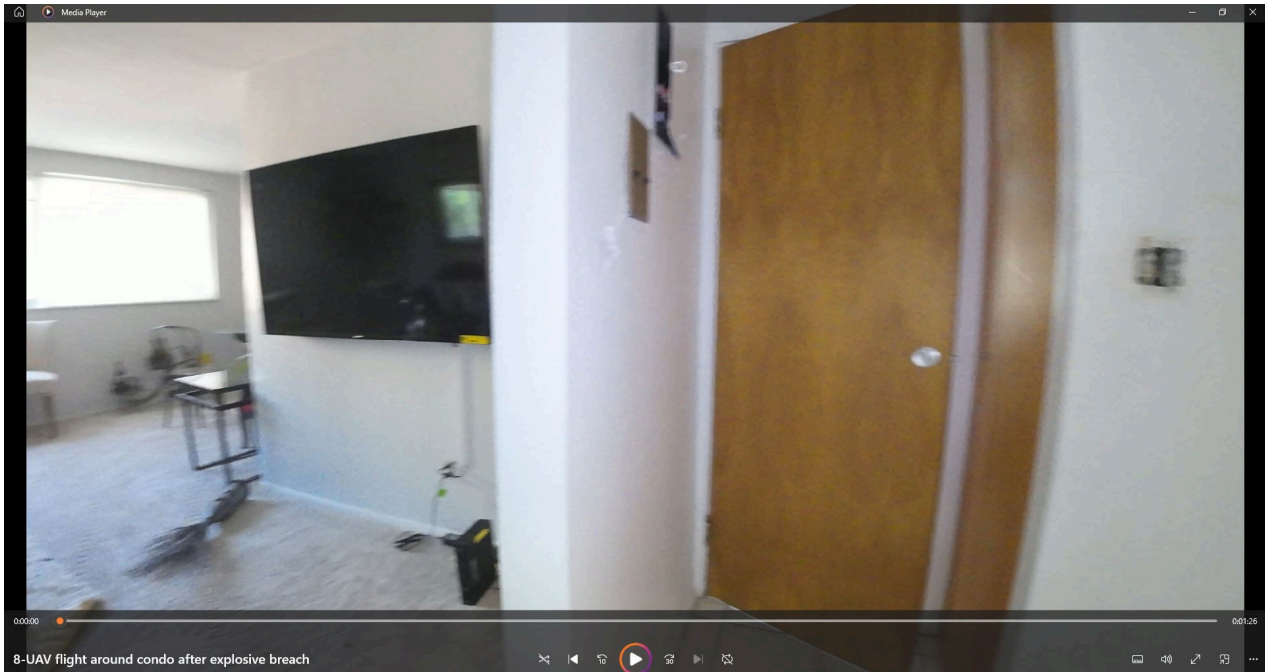

8-UAV flight around condo after explosive breach

This video clip was 1 minute and 26 seconds in duration (Image #10). During this video clip the drone continued to fly around the apartment before exiting the apartment.

This video clip was 3 minutes and 48 seconds in duration (Image #11). At the beginning of the video clip the drone was outside of the apartment building. At approximately 18 seconds into the video clip the drone entered the apartment building through a window (Image #12). At approximately 31 seconds into the video clip De'Shawn Vaughn (Vaughn) can be seen with his [Vaughn's] arm raised (Image #13). It should also be noted that there appeared to be a firearm next to Vaughn (Image #13). Vaughn then appeared to hit the drone causing it to fall to the ground. The drone then appeared to be covered with something where it remained for the rest of the video clip (image #14).

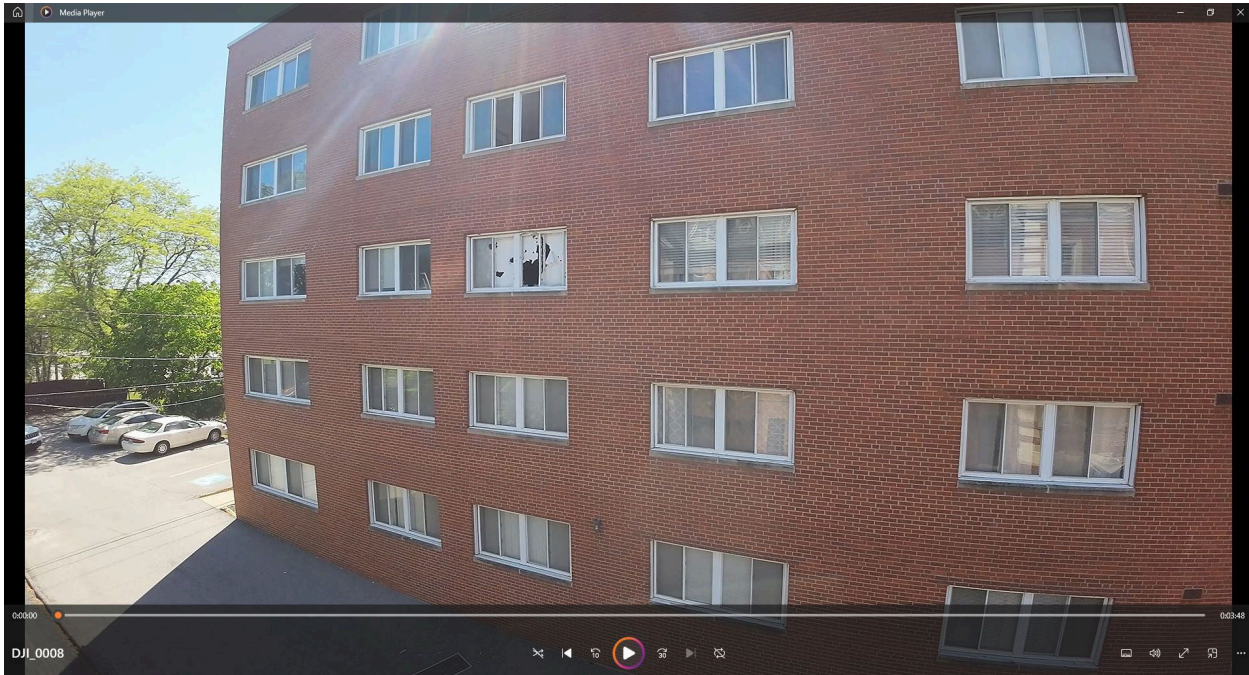

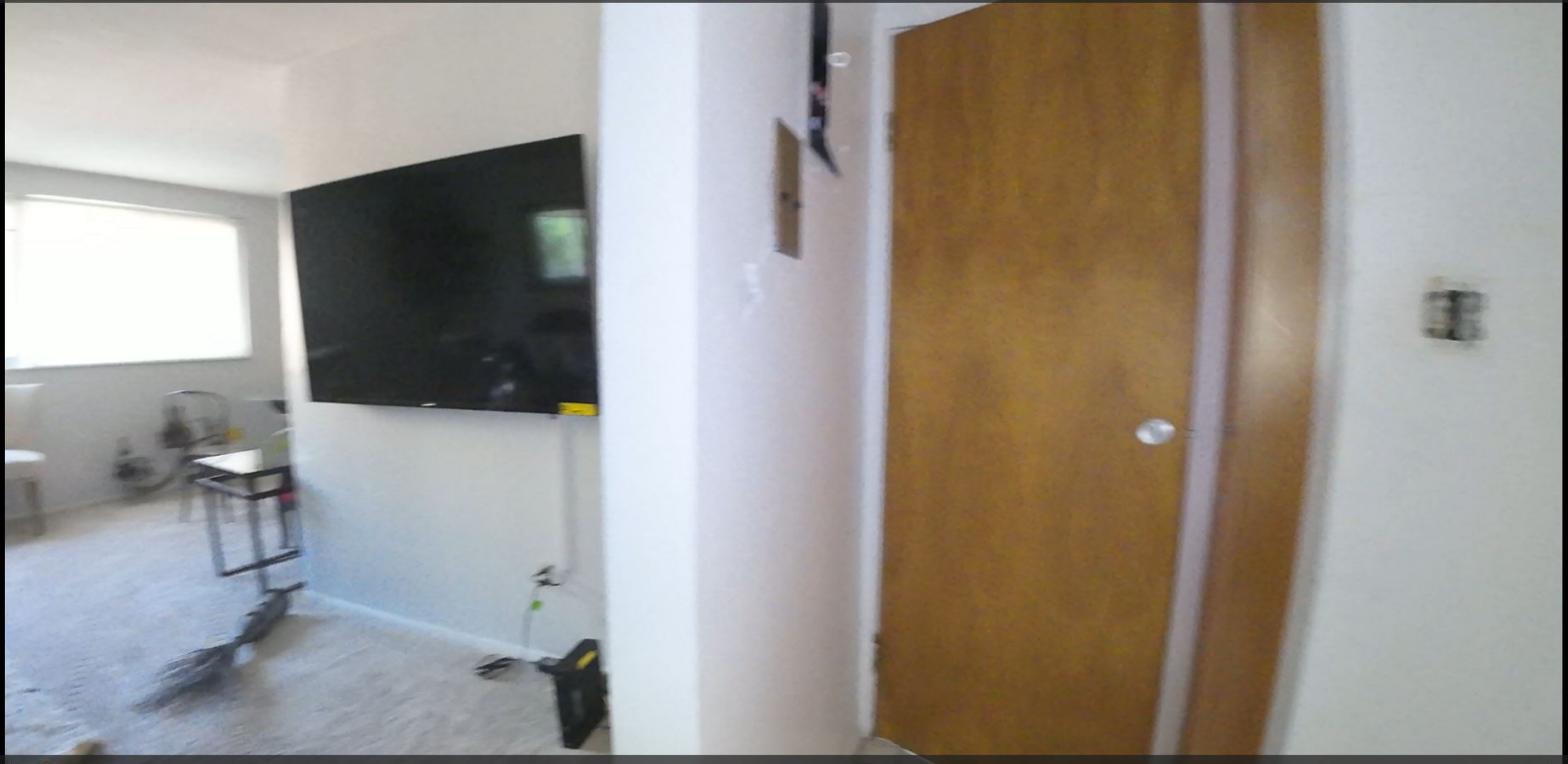

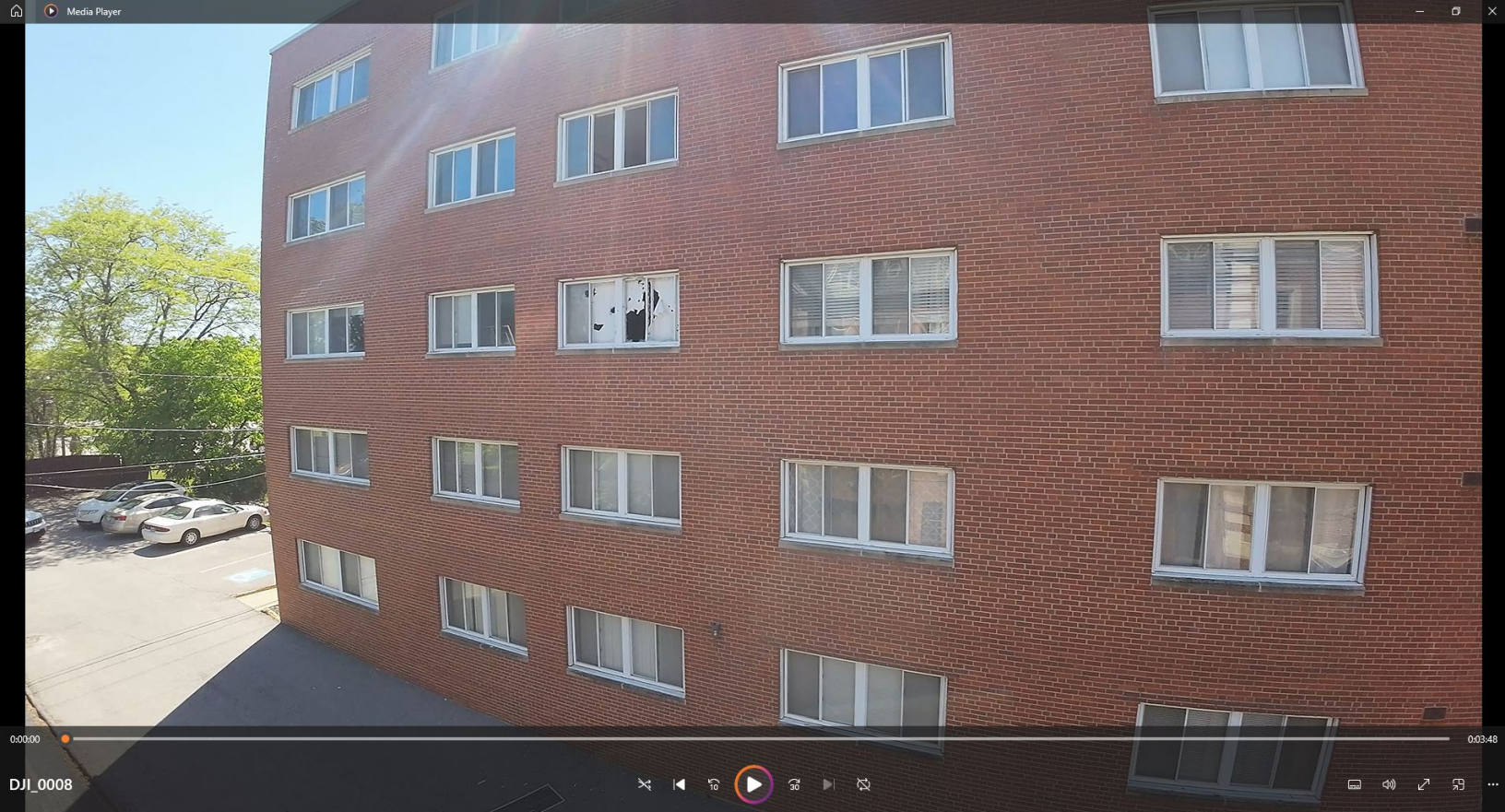
