**Narrative:**

On April 2, 2025, at 1348 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Lauren Frazier interviewed Anthony "Tony" Gouhin and Krista Owens, regarding the officer-involved critical incident which took place on April 1, 2025. The interview took place at Starbucks, located at 1064 State Route 28 in Milford, Ohio. The purpose of the interview was to obtain all relevant information of the incident known or observed by this individual.

SA Frazier was made aware by Ohio State Highway Patrol (OSHP) investigators that the HUB Intelligence Unit identified a vehicle as a possible witness to this incident. The vehicle was a 2004 silver Lincoln Aviator with OH plate# HUK8146. The vehicle owners were identified as Tabitha Baringhaus ( ) and John Baringhaus ( ). It was learned that the vehicle was being driven that night by Anthony "Tony" Gouhin ( ) and his girlfriend, Krista Owens ( ) was a passenger.

Tony Gouhin and Krista Owens said that they pulled up and saw a cruiser that was attempting to block traffic. They weren't sure what was happening, so they drove around the cruiser. Tony saw headlights facing him and slowed down. He said that he saw multiple officers enter the roadway and he pulled over to the right side of the road and stopped.

Krista Owens said that she started recording a video on her cell phone. Tony said that he saw a cruiser had a vehicle pinned against the median/retaining wall. He said that he saw five officers with weapons drawn, who were heard telling the driver, "let me see your hands" and "don't move." Tony said that the driver of the red vehicle was seen moving all over the place. He described that their head was moving and they were leaning over into the passenger seat.

Tony said that the officers couldn't gain access to the driver because the vehicle was pinned up against the cruiser and the wall. He observed an officer get into the cruiser and move it out of the way. Tony said that the driver did not appear to be compliant and was not giving up.

Tony said that he knew something was going to happen, so he drove around the incident and continued on I-275.

As soon as he passed by the incident, he said that he could see that the car came off of the wall, straight towards the officers, and he heard officers open fire. He said that the vehicle drove left after it came off the wall. Tony said that he did not hear any gunshots prior to passing the incident. He did not see the subject's firearm at any point.

Tony said that he heard through social media that the subject had a firearm and had fired first, but could not corroborate this information. Tony and Krista said that they heard multiple shots fired, described as approximately 2 shots, which they believe were fired by police.

Tony and Krista said that they had not seen the vehicle, prior to police stopping it. Krista said that she had posted the video of the incident on her personal Facebook page last night, but has since taken it down. She said that she took it down due to police and the news contacting her. Tony said that he did not record anything and neither of them were injured during the incident.

The interview concluded at approximately 1357 hours. A copy of the cell phone video taken by Krista Owens has been uploaded in Axon (see references). Agent Note: There are two copies of the video, one is the full video with bad quality, and another is a shortened clip with better quality. The interview was audio recorded and is attached to this report (attachment #01).
