DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Department of Public Works, for the Department of Public Welfare, and the Ardit Mosaic Tile and Marble Company of Columbus, Ohio. This contract covers the construction and completion of contract for general work on a project known as Reconstruction of Floors in Cottage I, Ohio Hos-

pital for Epileptics, Gallipolis, Ohio, in accordance with Item No. 1, Item No. 5 (Alt. G-4), Item No. 6 (Alt. G-5), Item No. 7 (Alt. G-6) and Item No. 8 (Alt. G-7) of the form of proposal dated August 29, 1932. Said contract calls for an expenditure of nine thousand five hundred and ninety-eight dollars (\$9,598.00).

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract. You have also shown that the Controlling Board has approved the expenditure of moneys for this contract, in accordance with Section 3 of House Bill No. 596 of the 89th General Assembly. In addition, you have submitted a contract bond, upon which the Royal Indemnity Company of New York City, New York, appears as surety, sufficient to cover the amount of the contract.

You have further submitted evidence indicating that plans were properly prepared and approved, notice to bidders was properly given, bids tabulated as required by law, and the contract duly awarded. Also it appears that the laws relating to the status of surety companies and the workmen's compensation have been complied with.

Finding said contract and bond in proper legal form, I have this day noted my approval thereon and return the same herewith to you, together with all other data submitted in this connection.
