Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) reviewed video footage from Akron Police Department (APD) Officer (Ofc.) [REDACTED] [REDACTED] body-worn camera (BWC). For a detailed review of the video footage leading up to and including the shooting incident refer to the report titled **2025-04-30: OCIC Video Presentation review**. The video review detailed in this report will begin where the report noted above left off.

SA Lieber reviewed the video recording and noted the following:

**Body-worn camera**

The video is titled [REDACTED] - 294 Ira and is 6 minutes and 34 seconds in duration. The timestamp at the beginning of the video is 09:09:38.

This report will begin the video review at 09:12:12. At that time, officers were approaching Marcus Smith (Marcus) as he was lying in the street.

At 09:12:19, officers had begun to move Marcus in an effort to locate the handgun he was observed using. A firearm, later identified as a Colt Detective Special, 38 caliber revolver, was observed by officers lying next to Marcus. Officers then pulled Marcus away from the firearm and into the middle of the street. The screenshot below shows the location of the revolver after officers began to move Marcus.
